## MASTER'S REPORT

Legacy Land Partners Limited Partnership claims 43B 192263-00 and 43B 192264-00 each appeared in the Preliminary Decree with the following remarks:

STARTING IN 2008, PERIOD OF DIVERSION WAS ADDED TO MOST CLAIM ABSTRACTS, INCLUDING THIS ONE.

POINT OF DIVERSION WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

Legacy Land Partners Limited Partnership objected to each claim. The State of Montana, Board of Land Commissioners ["State of Montana"] objected to each claim. The United States of America, Bureau of Reclamation ["BOR"], filed a notice of intent to appear on each claim.

On August 25, 2021 Legacy Land Partners Limited Partnership and the State of Montana filed a Stipulation For Implied Claim. Although generating implied claims is requested, the proper action is splitting the claims between the co-owners. On September 3, 2021 the BOR filed United States' Statement On Claimant's Stipulation which states that the changes requested in the Stipulation address its concerns. The settlement documents are viewable in the Court's FullCourt Enterprise case management system.

### APPLICABLE LAW

"All issue remarks to claims that are not resolved through the filing of an objection as provided in 85-2-233 must be resolved as provided in this section." Section 85-2-248(2), MCA.

If, at the time an appropriation is made, the appropriator is a lessee of school trust land and if the lessee makes and uses the appropriation on school trust land, the appropriation is owned by the State of Montana rather than the lessee. *Department of State Lands v. Pettibone*, 216 Mont. 361, 702 P2d 948 (1985). Implicit in this rule is the determination that the land was indeed fully vested as state school trust land at the time the appropriation was made. See *Findings of Fact, Conclusions of Law, and Memorandum*, Case No. 43A-A, June 29, 2000; *Opinion* (page 3), Case No. 41G-190, July 19, 2005, and *Opinion*, Case No. 41G-3, August 3, 2005.

The Water Court may split a claim with multiple owners into separate claims upon request of all of the claimants prior to issuance of the final decree. Rule 26, W.R.Adj.R.

A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content pursuant to section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect including for claimants objecting to their own claims. Rule 19, W.R.Adj.R.

#### FINDINGS OF FACT

1. The period of diversion and point of diversion remarks provide notice of these changes made prior to issuance of the Preliminary Decree and do not raise unresolved issues which need to be addressed. The remarks should be removed as having served their notice purposes.

2. For both stockwater claims 43B 192263-00 (USE right, priority date JUNE 1, 1924) and 43B 192264-00 (FILED right, priority date JUNE 1, 1929), the Statements of Claim and the Preliminary Decree include a parcel in the N2NWSW of section 36, T1S, R11E, PARK as part of the place of use. This parcel is school trust land. As stated in paragraph 8.b. and 8.c. of the Stipulation:

- b. On February 2, 1883, the General Land Office (GLO) survey for this parcel was accepted.
- c. On November 8, 1889, title to both parcels vested with the state according to the granting document, Patent Book vol. 3, pg. 429." Therefore, the State of Montana is a co-owner of each of these claimed rights.

The GLO Records copy attached to the Stipulation states the survey was approved/accepted on February 22, 1883 rather than February 2, 1883. This does not affect the analysis.

3. Claim 43B 192263-00 should be modified to represent only the Legacy Land Partners Limited Partnership portion of the claimed right. Split claim 43B 30153428 should be generated for the State of Montana portion of the claimed right.

4. Claim 43B 192263-00 should be modified as follows: the parcel in the N2NWSW section 36, T1S, R11E, PARK should be removed from the place of use.

5. The elements of claim 43B 30153428 should be the same as 43B 192263-00 except: 1) the owner should be STATE OF MONTANA, BOARD OF LAND COMMISSIONERS, and 2) the place of use should be GOVT LOT 1, N2NWSW section 36, T1S, R11E, PARK.

6. Claim 43B 192264-00 should be modified to represent only the Legacy Land Partners Limited Partnership portion of the claimed right. Split claim 43B 30153429 should be generated for the State of Montana portion of the claimed right.

7. Claim 43B 192264-00 should be modified as follows: the parcel in the N2NWSW section 36, T1S, R11E, PARK should be removed from the place of use.

8. The elements of claim 43B 30153429 should be the same as 43B 192264-00 except: 1) the owner should be STATE OF MONTANA, BOARD OF LAND COMMISSIONERS, and 2) the place of use should be GOVT LOT 1, N2NWSW section 36, T1S, R11E, PARK.

#### CONCLUSIONS OF LAW

The State of Montana is a co-owner of the rights claimed on 43B 192263-00 and 43B 192264-00.

The information provided by the parties is sufficient to split claims 43B 192263-00 and 43B 192264-00.

#### RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusions of Law, this Master recommends that the Court split claims 43B 192263-00 and 43B 192264-00, generate split claims 43B 30153428 and 43B 30153429, and make the changes specified in the Findings of Fact to correct the Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim for each claim is served with this Report to confirm the recommended changes have been made in the state's centralized record system.
