MASTER'S REPORT

FINDINGS OF FACT

39FJ 31858-00 and 39FJ 31859-00

1. Claims 39FJ 31858-00 and 39FJ 31859-00 received the following issue remark:

THE WATER COURT FINDS THIS CLAIM TO BE DUPLICATED BY CERTIFICATE NO. C036955-00, THEREFORE NO NEW WATER RIGHT CERTIFICATE WILL BE ISSUED.

2. Both claims were claimed with a September 16, 1981, priority date; the record supports the claimed priority dates.

3. On July 16, 2021, the Court ordered Claimant to file evidence showing claims 39FJ 31858-00 and 39FJ 31859-00 are not duplicates of Groundwater Certificate No. CO36955-00. The Order stated that “[i]f nothing is filed by the August 6, 2021 deadline, claims 39FJ 31858-00 and 39FJ 31859-00 will be dismissed.” Nothing was filed by the August 6, 2021, deadline.

5. None of the claims received objections.

PRINCIPLES OF LAW

1. Pursuant to Rule 1(a) of the Water Rights Adjudication Rules, the Water Court has jurisdiction over existing water rights. “Existing water right” means a right to the use of water that would be protected under the law as it existed prior to July 1, 1973.

Rule 2(a)(2), W.R.C.E.R.

2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R.

3. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.

4. A preponderance of the evidence is evidence that shows a fact is “more probable than not.” *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.

5. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).

6. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.

7. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

8. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

CONCLUSIONS OF LAW

39FJ 31858-00 and 39FJ 31859-00

1. Based on the record before Court and Rule 1(a), W.R.Adj.R., claims 39FJ 31858-00 and 39FJ 31859-00 are duplicates of Groundwater Certificate No. CO36955-00 and should be dismissed.

Notice-Type Issue Remarks

2. The notice-type issue remarks identify elements modified as a result of DNRC review pursuant to Montana Water Court reexamination orders. The remarks indicate that if no objections are filed, the elements of the claim will remain as they appear on the abstract and the remarks will be removed.

3. Each remark provides notice of the changes made after completion of the Temporary Preliminary Decree proceedings and prior to issuance of the Preliminary Decree. The remark does not raise unresolved issues that need to be addressed. No proceedings are required to resolve the remarks; the remarks should be removed from the abstracts.

RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court adopt the changes as outlined above.

A post decree abstract of each water right claim reflecting the recommended changes is attached to this Report.
