**MASTER'S REPORT**

**FINDINGS OF FACT**

1. Claims 40A 1620-00, 40A 198558-00, 40A 199407-00, and 40A 211380-00 were decreed with the following DNRC issue remark:

THE TYPE OF HISTORICAL RIGHT, PRIORITY DATE, AND FLOW RATE MAY BE QUESTIONABLE. THE CLAIMS FOLLOWING THIS STATEMENT USE THE SAME FILED APPROPRIATION TO DOCUMENT THE RIGHT. THE COMBINED FLOW RATE FOR THIS GROUP OF CLAIMS EXCEEDS THE TOTAL OF THE ORIGINAL APPROPRIATION. 40A 1620-00, 40A 198558-00, 40A 199407-00, 40A 211380-00.

The remark indicates that together, the flow rate of claims 40A1620-00, 40A 198558-00, 40A 199407-00, and 40A 211380-00 overclaim the Geo Crawford 1,200 miner's inch right (30 miner's inch (MI)) as follows:

2. Claim 40A 1620-00 was also decreed with the following DNRC issue remark:

AN AMENDMENT WAS SUBMITTED ON 05/23/2016 REQUESTING TO AMEND THE FLOW RATE. THE AMENDMENT WAS NOT PROCESSED. THE AMENDMENT WILL BE REVIEWED AFTER THE ISSUANCE OF THE PRELIMINARY DECREE.

On May 23, 2016, Roy S. O'Connor submitted an Amendment to the flow rate of claim 40A 1620-00, reducing the flow rate to 25.00 cubic feet per second (cfs) and resolving the over-filed notice of appropriation issue.

3. Claims 40A 1620-00 and 40A 199407-00 were decreed as filed rights with April 4, 1887 priority dates and the following issue remark:

THE PRIORITY DATE MAY BE QUESTIONABLE. THIS CLAIM IS FOR A FILED APPROPRIATION ON MUSSELHELL RIVER WITH A PRIORITY DATE PREDATING CASE NO. 1148, GOLDEN VALLEY COUNTY.

4. Claims 40A 211380-00 and 40A 211381-00 were decreed with the

following issue remarks:

CLAIM WAS NOT INCLUDED IN THE BASIN 40A TEMPORARY PRELIMINARY DECREE ISSUED 05/07/1985.

CLAIM FILED LATE 07/24/1985 . IN ADDITION TO BEING SUBORDINATE TO ALL INDIAN AND FEDERAL RESERVED WATER RIGHTS AND ALL VALID TIMELY FILED CLAIMS BASED ON STATE LAW, THIS RIGHT MAY ALSO BE SUBORDINATE TO CERTAIN PERMITS AND RESERVATIONS OF WATER. SEE SECTION 85-2-221 MCA.

5. No objections or notices or intent to appear were filed.

### PRINCIPLES AND CONCLUSIONS OF LAW

1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R.; *Nelson v. Brooks*, 2014 MT 120, 375 Mont.86, 95, 329 P.3d 558, 564.

2. With respect to the priority date of claims 40A 1620-00 and 40A 199407-00, the only evidence before the Court is the existence of Case No. 1184 and the resulting issue remark that appeared on claims 40A 1620-00 and 40A 199407-00. While historical decrees provide some evidence of existing water rights on a given source, they are not conclusive. Decrees were often the result of a specific controversy between water users; thus, rights were adjudicated on a piecemeal basis by the district courts. Further, decrees were usually limited in scope, and often multiple decrees were issued on the same stream. See Albert Stone, *Are There Any Adjudicated Streams in Montana?* 19 Mont. L. Rev. 19 (1957).

In short, there are numerous reasons why the claims in this Case may not have appeared in the District Court decree, but objectors bear the burden of establishing that the priority date should be something other than what was claimed. In this Case, the prima facie proof of priority date has not been overcome.

3. Claims 40A 211380-00 and 40A 211381-00 are late claims that did not appear in the Temporary Preliminary Decree for this Basin. The late claim issue remark that appeared on these claims gave notice that the claims could be subordinate and therefore junior to certain permits and reservations of water. Any party asserting a

superior claim to water based on a permit or reservation was required to file an objection to that late claim during the objection period. Because no such objections were filed, the remarks can now be removed from these late claims.

### RECOMMENDATIONS

1. The flow rate of claim 40A 1620-00 should be reduced to 25.00 cfs.
2. The issue remarks should be removed from the claims in this Case.

Post Decree Abstracts of Water Right Claims are served with the Report to confirm that the recommended changes have been made in the state's centralized record system.
