**ORDER APPROVING STIPULATION, VACATING SCHEDULING ORDER,
AND CLOSING CASE**

The City of Havre's flood control claims had issue remarks questioning the beneficial use of the water for the claimed purpose and questioning the volume and flow rate for the claimed purpose. The Water Court added the State of Montana as a party to assist with resolution of these remarks. No other parties objected to these claims.

On July 27, 2021, the City of Havre and the State of Montana filed a stipulation. Settlement agreements are subject to approval by the Water Court. Rule 17(a), W.R.Adj.R.

The stipulation between the City of Havre and the State of Montana is a settlement binding on the parties to that agreement. By approving it, this Court expresses no opinion on its enforceability by or against other parties. Likewise, this Court expresses no opinion on the information remarks referenced in the stipulation.

The stipulation did not request changes to any element of the claims, but did request the addition of three information remarks to each claim.

The issue remarks have been removed and the parties' requested information remarks have been added. These claims shall appear in the Final Decree for Basin 40J as shown on the abstracts attached to this order.

The deadlines set in the March 25, 2021 Scheduling Order are VACATED.

This case is closed.
