#### **MASTER'S REPORT**

## INTRODUCTION

Multiple use water rights claims 41H 32975-00 and 41H 32977-00, owned by Richard, Robert, and William Breffeilh, appeared in the Preliminary Decree for the Gallatin

River (Basin 41H). The claim's preliminary decree abstract indicates the multiple-use claims are for surface water direct from the West Gallatin River in the SW of Section 20, Township 4S, Range 4E, Gallatin County, Montana.

The United States Forest Service (USFS) filed an objection to the water right claim's place of use and point of diversion as it appeared in the preliminary decree, stating: "The claimed point of diversion and place of use includes federal land in the National Forest System. The point of diversion and place of use should be refined to exclude federal land and a remark should be added that states that the point of diversion and place of use are entirely on private lands."

To discuss the objection, the Water Court consolidated the water right claim into Water Court case 41H-0165-R-2021 and held a status conference attended by counsel Romney Philpott for the USFS and Robert and William Breffeilh. The parties indicated they were close to resolving the issue and that a settlement filing deadline was appropriate. On July 21, 2021, the parties filed a Stipulation to Resolve Objections with the court resolving the issue. Because water rights claims 41H 32975-00 and 41H 32977-00 are multiple uses of the same originally filed water right, the Water Court calls claim 41H 32977-00 in on motion to resolve the issue consistently between the multiple-use water rights.

The Water Court presently resolves the issue in this case.

## **ISSUES**

1. Whether the Water Court approves the stipulation filed by the parties and adds the requested information remark to the claims' decree abstracts.

### APPLICABLE LAW

"The Montana [W]ater [C]ourt has a statutory obligation and the exclusive authority to adjudicate claims of existing water rights." Rule 1(a), W.R.Adj.R. The Water Court resolves issue remarks before issuance of a final decree and may use information submitted by the DNRC, the statement of claim, and any other data obtained by the court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

After the Water Court issues a preliminary decree in a basin, an objection period provides parties with an ownership interest in water or its use the opportunity to raise issues

regarding their own water rights or other water rights in the preliminary decree. Section 85-2-233(1)(b); *Mont. Trout Unlimited v. Beaverhead Water Co.*, 2011 MT 151, ¶ 33, 361 Mont. 77, 255 P.3d 179.

A properly filed statement of claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628. The party seeking to overcome the prima facie status of a statement of claim bears the burden of proof. *Nelson v. Brooks*, 2014 MT 120, ¶¶ 34, 37, 375 Mont. 86, 329 P.3d 558.

In Water Court proceedings, the parties may file settlements stipulating the terms under which the parties contractually agree to resolve decree objections. A settlement may include a claimant's legally binding commitment to modify water right claims to resolve objections and issue remarks and an objector's agreement to withdraw objections conditioned upon the court's acceptance of the claim modifications. *E.g., In re Pondera Cty. Canal & Reservoir Co.*, Case 41M-202, 2020 Mont. Water LEXIS 19 (Jan. 9, 2020).

Settlement agreements do not bind the Water Court and are subject to the court's review and approval. Rule 17(a), W.R.Adj.R. The court may rely on the stipulated facts and agreements of a settlement that are "not contrary to law, court rule, or public policy." *In re Marriage of Hill*, 265 Mont. 52, 58, 874 P.2d 705, 708 (1994). When a stipulation proposes modifications to water right claim elements, the court must evaluate each proposed modification to ensure the modification is supported by the evidence and within the court's authority to adjudicate. *In re Argabright*, Case 41I-265, 2014 Mont. Water LEXIS 9, (December 12, 2014) (affirming rejection of stipulation); *In re Dana Ranch Co.*, Case 41J-265, 2017 Mont. Water LEXIS 13 (rejecting stipulation). The water right adjudication rules require settlement agreements enlarging an element of a water right to meet the applicable burden of proof. Rule 17(b), W.R.Adj.R. The rules do not require settlement agreements reducing an element of a water right to meet the applicable burden of proof. Rule 17(c), W.R.Adj.R.

## DISCUSSION

1. Whether the Water Court approves the stipulation filed by the parties and adds the requested information remark to the claims' decree abstracts.

The claim's preliminary decree abstract indicates multiple-use water rights claims 41H 32975-00 (stock) and 41H 32977-00 (domestic) are use rights for surface water from the West Gallatin River in Gallatin County, Montana.

The United States Forest Service filed an objection to the place of use and point of diversion for water right claim 41H 32975-00, stating: "The claimed point of diversion and place of use includes federal land in the National Forest System. The point of diversion and place of use should be refined to exclude federal land and a remark should be added that states that the point of diversion and place of use are entirely on private lands."

The signed Stipulation Resolving Objections asks the Water Court to add the following information remark to the post-decree abstracts for both multiple-use water rights claims 41H 32975-00 and 41H 32977-00:

THE PLACE OF USE AND POINT OF DIVERSION ARE LOCATED ENTIRELY ON PRIVATE LANDS AND DO NOT INCLUDE THE NATIONAL FOREST LANDS LOCATED IN THE SWSW OF SECTION 20, TOWNSHIP 4 SOUTH, RANGE 4 EAST.

Based on the court's review, the stipulation is not contrary to law, court rule, or public policy. The stipulation does not propose modifications enlarging any element of water right claim 41H 32975-00 or water right claim 41H 32977-00. The Water Court approves the stipulation filed by the parties and modifies the claims' decree abstracts by adding the requested information remarks. Approval of the stipulation resolves the objection filed by USFS.

#### RECOMMENDATIONS

This Water Master recommends the Water Court to add the following information remark to the decree abstracts for multiple-use water rights claims 41H 32975-00 and 41H 32977-00:

THE PLACE OF USE AND POINT OF DIVERSION ARE LOCATED ENTIRELY ON PRIVATE LANDS AND DO NOT INCLUDE THE NATIONAL FOREST LANDS LOCATED IN THE SWSW OF SECTION 20, TOWNSHIP 4 SOUTH, RANGE 4 EAST.

The Water Court attaches post-decree abstracts for water rights claims 41H 32975-00 and 41H 32977-00 to this Master's Report to reflect the changes made.

#### STIPULATION TO RESOLVE OBJECTIONS

This Stipulation, entered into by Objector United States of America (USDA Forest Service) ("United States") and Claimants Richard A. Breffeilh; Robert A. Breffeilh; William A. Breffeilh ("Claimants"), is for the purpose of resolving the United States' objection as to Water Right Claim No. 41H 32975-00, and to address a similar circumstance with respect to 41H 32977-00. This Stipulation is entered into as of the last date accompanying the signatures below.

#### RECITALS

- Pursuant to Mont. Code Ann. § 85-2-221, Claimants' predecessors timely filed A. Statements of Claim for Water Right Claim Nos. 41H 32975-00 and 41H 32977-00 with the Department of Natural Resources and Conservation ("DNRC").
- В. Claimants are owners of the Water Right Claim Nos. 41H 32975-00 and 41H 32977-00.
- C. Pursuant to Mont. Code Ann. § 85-2-233, the United States timely filed a Notice of Objection to Statement of Claim for Water Right Claim No. 41H 32975-00 with DNRC.

Stipulation

D. Water Right Claim Nos. 41H 32975-00 and 41H 32977-00 were included in the Basin 41H Preliminary Decree with the following information remarks:

THE WATER RIGHTS LISTED FOLLOWING THE STATEMENT ARE MULTIPLE USES OF THE SAME RIGHT. THE USE OF THIS RIGHT FOR SEVERAL PURPOSES DOES NOT INCREASE THE EXTENT OF THE WATER RIGHT, RATHER IT DECREES THE RIGHT TO ALTERNATIVE AND EXCHANGE THE USE (PURPOSE) OF THE WATER IN ACCORD WITH HISTORICAL PURPOSES.

- E. Water Right Claim Nos. 41H 32975-00 is a filed right for stock use of water from the West Gallatin River with a diversion means of "livestock direct from source." Water Right Claim Nos. 41H 32975-00 identifies the point of diversion and place of use as occurring in the SW ¼ of Section 20, Township 4 South, Range 4 East, in Gallatin County. As described, the descriptions of the point of diversion and place of use are overbroad and could be interpreted as inaccurately encompassing certain federal lands in the National Forest System. Claimants do not divert water or use water under this claim on any federal lands.
- F. Water Right Claim Nos. 41H 32977-00 is for a domestic water right, and identifies the point of diversion and place of use as occurring in the SW ¼ of the NW ¼ of the SW ¼ of Section 20, Township 4 South, Range 4 East, in Gallatin County. As described, the descriptions of the point of diversion and place of use are overbroad and could be interpreted as inaccurately encompassing certain federal lands in the National Forest System. Claimants do not divert water or use water under this claim on any federal lands.
- G. In the interest of resolving this case without the need for further litigation, the parties have executed this Stipulation.

#### **AGREEMENTS**

The parties stipulate as follows:

## 1. Water Right Claim Nos. 41H 32975-00

1.1 The place of use and point of diversion for Water Right Claim No. 41H 32975-00 are located solely on private lands, and do not include those National Forest System lands located in the SW ½ SW ½ of Section 20, Township 4 South, Range 4 East.

Stipulation Case No. 41H-0165-R-2021 1.2 The following information remark should be therefore added to the decree abstract for this claim:

- 5. The terms of this Stipulation are binding on the parties, their successors, and assigns. Nothing in this Stipulation shall create any right, claim, cause of action, objection, defense, or other remedy in any person not a party to the Stipulation.
- 6. Each party agrees to bear its own costs and attorney fees arising from the negotiation and execution of the Stipulation and in proceedings before the Montana Water Court regarding the Claims in this case.




