The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

MASTER'S REPORT

INTRODUCTION

Water rights claims 41H 141237-00, 41H 141239-00, and 41H 141241-00 appeared in the Preliminary Decree for the Gallatin River (Basin 41H) with issue remarks received

during the Department of Natural Resources and Conservation's (DNRC) review in preparation of the preliminary decree.

The Water Court consolidated the water rights claims into Water Court case 41H-0977-R-2021 and set filing deadlines for BNSF, the claims' owner per DNRC's water rights database, to file information resolving the issue remarks. On August 24, 2021, John Tietz, counsel for BNSF, filed a response with the Water Court.

The Water Court presently resolves the issue in this case.

ISSUES

1. Whether the Water Court dismisses water right claims 41H 141239-00 and 41H 141241-00 from the adjudication process by request.

APPLICABLE LAW

"The Montana [W]ater [C]ourt has a statutory obligation and the exclusive authority to adjudicate claims of existing water rights." Rule 1(a), W.R.Adj.R. The Water Court resolves issue remarks before issuance of a final decree and may use information submitted by the DNRC, the statement of claim, and any other data obtained by the court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

DISCUSSION

1. Whether the Water Court dismisses water right claims 41H 141239-00 and 41H 141241-00 from the adjudication process by request.

The response filed by BNSF requests the Water Court to dismiss water rights claims 41H 141239-00 and 41H 141241-00 from the adjudication process. The response states: "BNSF's investigation into the historical use of claim[s] 41H 141239-00 and 41H 141241-00] indicate[s] that water has not been diverted pursuant to [those claims] for a very long time, and the claim[s] ha[ve] therefore been abandoned." The court grants BNSF's request and dismisses the water rights claims from the adjudication process.

The response additionally indicates BNSF sold the place of use associated with appurtenant water right claim 41H 141237-00 to Montana Rail Link (MRL) on October 30, 1987. BNSF attached the quitclaim deed, which does not reserve the water right claim to BNSF. Therefore, the Water Court notices MRL, through courtesy copy, that MRL potentially owns an interest in water right claim 41H 141237-00. Ownership has not yet been updated in DNRC's water rights database. While the court has the quitclaim deed

evidencing BNSF sold the property at issue to MRL in 1987, the Water Court does not have information indicating MRL presently owns the water right claim and does not update ownership at this time. Water right claim 41H 141237-00 received a “notice only” issue remark, which is hereby removed, resolving the only issue regarding that water right claim. MRL can further update ownership by contacting the Bozeman DNRC’s office.

RECOMMENDATIONS

This Water Master recommends the Water Court to dismiss water rights claims 41H 141239-00 and 41H 141241-00, and to remove the resolved issue remarks from water right claim 41H 141237-00. The court attaches post-decree abstracts for the water rights claims to this Master’s Report to reflect the changes made.
