**ORDER INCORPORATING TERMS OF SETTLEMENT AGREEMENTS AND
CLOSING CASE**

I. INTRODUCTION

Water right claim 41M 131103-00 is owned by Cheryl S. and Gene R. Curry. Claim 41M 199796-00 is owned by Pondera County Canal & Reservoir Co. (“PCCRC”). For 41M 131103-00, PCCRC objected. For 41M 199796-00, PCCRC and the United States (Bureau of Indian Affairs) (“BIA”) objected, Daryle E. Swanson counterobjected, and Gene R. Curry and the Blackfeet Tribe filed an NOIA.

The Court dismissed Swanson during the August 2, 2021 pretrial conference as a sanction for failure to appear at the pretrial conference and failure to file a proposed pretrial order.

On October 16, 2020, PCCRC and Curry filed a Mediation Settlement Agreement. The Court issued an order approving the October 16 settlement agreement on October 21, 2020.

On August 12, 2021, the BIA, the Blackfoot Tribe, and PCCRC filed a Stipulation to Resolve Objections which addressed 41M 199796-00. The Court issued an order approving the August 12 stipulation on August 13, 2021.

II. ANALYSIS

October 16 Mediation Settlement Agreement

The October 16 agreement proposes changes to the point of diversion legal description (for the Ryan-Lauffer Ditch) for 41M 131103-00 and 41M 199796-00. For 41M 131103-00, the parties request the addition of an information remark referencing a distribution agreement. For 41M 199796-00, the parties request the addition of information remarks clarifying this claim's use of Swift Reservoir and referencing use of water approved through a DNRC Change Authorization. The agreement also proposes a reduction in the flow rate for 41M 199796-00 from 18.75 CFS to 9.375 CFS.

The October 16 agreement resolves PCCRC's objection to 41M 131103-00 and Curry's NOIA on 41M 199796-00.

The flow rate and acres irrigated issue remarks on 41M 131103-00 are resolved pursuant to the Order Amending and Partially Adopting Master's Report in WC-2006-01.

August 12 Stipulation

The August 12 stipulation only addresses 41M 199796-00. The stipulation proposes reducing the flow rate to 9.375 CFS. This reduction is consistent with the reduction requested in the October 16 agreement.

The stipulation requests changes to the point of diversion legal description and means of diversion for the Ryan-Lauffer Ditch. The point of diversion legal description change is consistent with the change requested in the October 16 agreement.

The August 12 stipulation also requests information remarks be added regarding multiple use and supplemental relationships, and limitations to the diversion rate from the Ryan Lauffer Ditch¹.

¹ There are two different versions of the information remark limiting the combined diversion rate for water rights utilizing the Ryan Lauffer Ditch – one included in Agreement 9.c.iii. of the stipulation and one included in Exhibit 7 (41M 199796-00 proposed abstract) attached to the stipulation. Because the Agreements are part of the executed

The August 12 stipulation resolves PCCRC's and BIA's objections and the Blackfeet Tribe's NOIA for 41M 199796-00.

III. CONCLUSION AND ORDER

The stipulations are approved. The issue remarks are resolved and removed. The requested changes have been made to both claims. The objections, counterobjections, and NOIAs are resolved. Claims 41M 131103-00 and 41M 199796-00 will appear in the Basin 41M Final Decree as shown on the post decree abstracts attached to this order.

This case is CLOSED.
