NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Clerk of the Montana Water Court. Please review this Report carefully.

You may file a written objection to this Master's Report if you disagree or find errors with the Master's Findings of Fact, Conclusions of Law, or Recommendations. The above stamped date indicates the date this Master's Report was filed and mailed. Rule 23 of the Water Right Adjudication Rules requires written objections to a Master's Report be filed within 10 days of the date of the Master's Report. Because this Master's Report was mailed to you, Rule 6(d) of the Montana Rules of Civil Procedure provides an additional 3 days to the 10-day objection period.

If you file an objection, you must mail a copy of the objection to all parties on the Service List found at the end of this Master's Report. The original objection and a certificate of mailing to all parties on the Service List must be filed with the Water Court. *If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.*

MASTER'S REPORT

The above-captioned claim appeared in the Preliminary Decree for Basin 43A. Claim 43A 18874-00 received an objection from Garth Sasser and Nancy Sasse Sasser. The claim was consolidated into Case 43A-0243-R-2021 to resolve the objection.

FINDINGS OF FACT

1. A Status Conference for Case 43A-0243-R-2021 took place on April 7, 2021, by telephone conference call. Water Master Eugene C. White presided; Objectors Garth Sasser and Nancy Sasse Sasser were present on behalf of themselves and Claimant Sasser Living Trust May 3, 1999.

2. During the conference, Mr. Sasser described the Sasser's objection including the need to clarify the name of the trust, removal of deceased claimants Alfred and Eva Sasser from the water right, and the need to modify the place of use ID 4 element of the claim.

3. On April 9, 2021, the Court set a filing deadline for the Sassers to file information or evidence and a map pertaining to the resolution of the objection and noting that the Court could make the clerical updates to the trust named as claimant, but that removal of former claimant required an ownership update through the DNRC. That deadline was extended in an Order on May 18, 2021.

4. On May 24, 2021, the Sassers filed a *Response*. In the *Response*, the Sassers state that the place of use for claim 43A 18874-00 should be modified from N2SE Sec 4, Twp 2N, Rge 10E, Park County, to N2NWSE Sec 4, Twp 2N, Rge 10E, Park County. The Sassers' *Response* includes a map showing the portion of property they own in Sec 4, Twp 2N, Rge 10E, Park County.

PRINCIPLES OF LAW

1. A properly filed Statement of Claim for an existing water right is *prima facie* proof of its content. Section 85-2-227, MCA; Rule 10, W.R.ADJ.R.

2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.

3. A preponderance of the evidence is evidence that shows a fact is “more probable than not.” *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.

4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).

5. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

6. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.

CONCLUSIONS OF LAW

1. The trust name and address should be updated to reflect current ownership as described in Finding of Fact No. 3, however, all claimants appearing on the abstract will appear until an ownership update is filed with the DNRC.

2. The requested modification of the place of use for ID 4 of claim 43A 18874-00 constitutes a reduction in the elements of the claim such that the Court may accept the requested reduction or limitation “without further presentation of evidence.” Rule 17(c), W.R.Adj.R. The objection for claim 43A 18874-00 is resolved.

RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court adopt the changes as outlined above.

A post decree abstract of the water right claim reflecting the recommended changes is attached to this Report.
