MASTER'S REPORT

FINDINGS OF FACT

1. The above-captioned claims appeared in the 43D Preliminary Decree issued March 7, 2017 and are owned by Sunlight Ranch Co. (Sunlight). The claims received issue remarks from the DNRC and/or objections from the claimant.

2. On March 31, 2021, Sunlight filed a Stipulation concerning the claims in this case. A filing deadline was set for Sunlight to submit additional evidence to support the terms of the Stipulation. On July 9, 2021, Sunlight submitted a response. The response referenced Exhibits A, B, and C. However, no exhibits were attached to the July 9, 2021 response. On August 11, 2021, an email was sent to counsel for Sunlight indicating the exhibits were not attached and requesting Sunlight file the referenced exhibits by the end of the month. By September 3, 2021, no exhibits had been filed. An Order Setting Filing Deadline was issued for Sunlight to file the referenced exhibits or face dismissal of its objections. Nothing was filed by the deadline.

3. Claims 43D 31270-00, 43D 31271-00, 43D 31274-00, 43D 31283-00, 43D 31287-00, 43D 31289-00, 43D 31290-00, 43D 31291-00, 43D 31292-00, and 43D 31293-00 did not receive any issue remarks. The only modifications sought by the claimant are to the periods of use and periods of diversion. The claimant did not provide evidence in support of the requested modifications. A deadline was set for Sunlight to submit additional evidence. In its July 9, 2021 response, Sunlight states it was, "unable to find any living witness or tangible evidence that proves such historic use," and withdrew its objections to these claims.

Claim 43D 13899-00

4. Claim 43D 13899-00 received the following three issue remarks:

AN AMENDMENT WAS SUBMITTED ON 02/29/2016 REQUESTING TO AMEND THE POINT OF DIVERSION. THE AMENDMENT WAS NOT PROCESSED. THE AMENDMENT WILL BE REVIEWED AFTER THE ISSUANCE OF THE PRELIMINARY DECREE.

AN AMENDMENT WAS SUBMITTED ON 03/03/2016 REQUESTING TO AMEND THE PLACE OF USE. THE AMENDMENT WAS NOT PROCESSED. THE AMENDMENT WILL BE REVIEWED BY THE COURT AFTER THE ISSUANCE OF THE PRELIMINARY DECREE.

THE CLAIMED FLOW RATE OR VOLUME MAY BE INCORRECT. BASED ON THE FLOW RATE AND PERIOD OF USE, THE SYSTEM WOULD HAVE TO RUN 24 HOURS PER DAY TO DELIVER THE CLAIMED VOLUME. NO INFORMATION EXISTS IN THE CLAIM FILE TO CONFIRM THESE FIGURES.

The 2016 amendments referenced in the first two issue remarks can be found in the claim file, but the amendments did not include any evidence in support. A filing deadline was set for the claimant to submit evidence in support of the amendments. In its July 9, 2021 response, Sunlight did not provide any evidence in support of the amendments and withdrew its objection to claim 43D 13899-00. Both issue remarks concerning the amendments filed in 2016 should be removed from the claim.

The third issue remark concerning the claimed flow rate and volume does not overcome the *prima facie* status of the claim. The issue remark states that the system would have to run 24 hours a day to deliver the claimed volume. In a May 2, 1989 letter from the DNRC, a water right specialist wrote, “you mentioned that the water runs almost all year long, in the summer for irrigating and in the winter to keep the line from freezing. If your claimed flow rate of 3 gallons per minute was run all year long, it would equal 4.85 acre feet per year.” Accordingly, the volume (4.85 AF) and flow rate (3 gpm) are reasonable, and the issue remark should be removed from the claim.

Claims 43D 31271-00, 43D 31274-00 and 43D 31287-00

5. Claims 43D 31271-00, 43D 31274-00 and 43D 31287-00 did not receive any DNRC issue remarks. The claimant objected to the three claims asserting that the period of use and period of diversion should be modified to year-round. Sunlight did not provide evidence in support of a year-round period of use and period of diversion. A filing deadline was set for Sunlight to submit evidence. In its July 9, 2021 response, Sunlight discussed an affidavit of John Dean Webb in support of its objections.

Unfortunately, the John Dean Webb affidavit (Exhibit A) was not attached to the July 9, 2021 filing. Counsel was informed of the deficiency via an August 11, 2021 email to counsel and a September 3, 2021 Order Setting Filing Deadline. The referenced affidavit from John Dean Webb has not been filed with the Court. There has been no

evidence presented to support Sunlight's assertion that claims 43D 31271-00, 43D 31274-00 and 43D 31287-00 have historically been used year-round.

This case was consolidated over two years ago. Sunlight has been granted numerous extensions to provide evidence in support of its objections. The most recent order indicated that failure to respond would result in dismissal of Sunlight's objections. Sunlight has failed to provide evidence overcoming the *prima facie* status of claims 43D 31271-00, 43D 31274-00 and 43D 31287-00. No changes should be made to the elements of claims 43D 31271-00, 43D 31274-00 and 43D 31287-00. Sunlight's objections to the claims should be dismissed.

Claim 43D 31279-00

Claim 43D 31279-00 did not receive any issue remarks from the DNRC. Sunlight objected to the place of use, maximum acres, point of diversion, and means of diversion. The objection states, "Needs refinement to address POU and POD." In its March 31, 2021 Stipulation, Sunlight requested changes to the place of use, the point of diversion, and the source.

In the Preliminary Decree, claim 43D 31279-00 appeared with a place of use and point of diversion in the SENENW of Section 19, T8S, R21E. The source was identified as "Spring, Unnamed Tributary of Wolf Creek."

In its Stipulation, Sunlight requests the place of use and point of diversion be modified to the SWNENW of Section 19 and the source be changed to "Wolf Creek." Sunlight attached a map, "Exhibit B," to the March 31, 2021 Stipulation showing the requested point of diversion and place of use.

Exhibit B to the March 31, 2021 Stipulation is a PLSS Map Viewer dated March 26, 2021; it is not sufficient to support Sunlight's assertion concerning the historical use of claim 43D 31279-00. A filing deadline was set for Sunlight to provide additional evidence.

On July 9, 2021, Sunlight filed a response and discussed "a more detailed Exhibit B." Unfortunately, Exhibit B was not attached to the July 9, 2021 filing. Counsel was informed of the deficiency via an August 11, 2021 email to counsel and a September 3, 2021 Order Setting Filing Deadline. A more detailed Exhibit B has not been filed with

the Court. Sunlight has not filed evidence sufficient to support the requested modifications to place of use, point of diversion, and source for claim 43D 31279-00.

This case was consolidated over two years ago. Sunlight has been granted numerous extensions to provide evidence in support of its objections. The most recent order indicated that failure to respond would result in dismissal of Sunlight's objections. Sunlight has failed to provide evidence overcoming the *prima facie* status of claim 43D 31279-00. No changes should be made to the elements of claim 43D 31279-00. Sunlight's objection should be dismissed.

Claim 43D 31284-00 and 43D 31285-00

Claims 43D 31284-00 and 43D 31285-00 did not receive any DNRC issue remarks. Sunlight Ranch objected to several elements of the claims stating, "needs refinement to address POU, POD, and flow rate. Period of Diversion should be amended to 12 months."

In its March 31, 2021 Stipulation, Sunlight indicated that claims 43D 31284-00 and 43D 31285-00 should be modified as follows:

The only evidence in support of these requested modifications to the claims was a map attached to the March 31, 2021 stipulation as Exhibit C. The map only has one arrow depicting a point of diversion and place of use. The arrow appears to be pointing at the SWSWSW of Section 13, which does not align with either the decreed place of use/point of diversion, or the requested place of use/point of diversion. The map did not support the requested modifications to claims 43D 31284-00 and 43D 31285-00.

A filing deadline was set for Sunlight to provide additional evidence in support of the requested modifications.

On July 9, 2021, Sunlight filed a response and discussed "a more detailed Exhibit C, an aerial photograph showing the decreed points of diversion and places of use for

43D 31284-00 (in blue) and 43D 31285-00 (in red)." Unfortunately, Exhibit C was not attached to the July 9, 2021 filing. Counsel was informed of the deficiency via an August 11, 2021 email to counsel and a September 3, 2021 Order Setting Filing Deadline. A more detailed Exhibit C has not been filed with the Court. Sunlight has not filed evidence sufficient to support the requested modifications to claims 43D 31284-00 and 43D 31285-00.

This case was consolidated over two years ago. Sunlight has been granted numerous extensions to provide evidence in support of its objections. The most recent order indicated that failure to respond would result in dismissal of Sunlight's objections. Sunlight has failed to provide evidence overcoming the *prima facie* status of claims 43D 31284-00 and 43D 31285-00.

No changes should be made to the elements of claims 43D 31284-00 and 43D 31285-00. Sunlight's objections should be dismissed.

Claims 43D 206859-00 and 43D 206860-00

Claims 43D 206859-00 and 43D 206860-00 did not receive any DNRC issue remarks. Sunlight objected to the claims and proposed adding additional places of use. A deadline was set for Sunlight to file evidence in support of the requested changes and to address the binding nature of an October 15, 1998 Stipulation entered into between Sunlight's predecessors and the United States Bureau of Land Management.

In its July 9, 2021 Stipulation, Sunlight states it "has been unable to find any living witness or tangible evidence that proves the water was used at the proposed additional places of use before July 1, 1973." Sunlight withdrew its objections to claims 43D 206859-00 and 43D 206860-00.

Claim 43D 206861-00

Claim 43D 206861-00 received a notice issue remark from the DNRC stating the point of diversion and source name were modified as a result of DNRC review under reexamination. The remark states that if no objections are filed to this claim, the elements will remain as they appear on the abstract and the remark will be removed.

Sunlight objected to the claim seeking to add additional places of use. A filing deadline was set for the claimant to file additional evidence in support of the requested

modification. In its July 9, 2021 Stipulation, Sunlight states it “has been unable to find any living witness or tangible evidence that proves the water was used at the proposed additional places of use before July 1, 1973.” Sunlight withdrew its objection to claim 43D 206861-00.

The elements of the claim should remain as they appeared in 43D Preliminary Decree, and the notice issue remark should be removed from the claim.

CONCLUSIONS OF LAW

1. A properly filed claim of an existing right or an amended claim of existing right is *prima facie* proof of its content. § 85-2-227, MCA. This *prima facie* proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.

2. Section 85-2-248(2), MCA requires the Water Court to resolve all issue remarks that are not resolved through the objection process. The Montana Water Court has the authority to resolve issue remarks when the claim file and information available to the Court provide a sufficient basis to do so. § 85-2-248(3), MCA.

The issue remarks appearing on the claims in this case do not overcome the *prima facie* status of the claims.

The flow rate and volume for claim 43D 13899-00 are supported by the record; the issue remark concerning flow rate and volume should be removed. Additionally, claim 43D 13899-00 received issue remarks concerning unaddressed amendments that were filed in 2016. The amendments were not supported by evidence and do not overcome the *prima facie* status of the claim. No changes should be made to the elements of the claim and the amendment remarks should be removed.

Claim 43D 206861-00 received a notice issue remark indicating that the point of diversion and source name were modified during the DNRC reexamination process. The remark is a notice issue remark. A notice issue remarks provides notice of certain aspects

of a claim; the remark does not overcome the *prima facie* status of the claim. The notice issue remark should be removed from claim 43D 206861-00.

3. If a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing, or fails to comply with an order issued by the water court, the water court, upon motion, or its own initiative, may issue such orders of sanction with regard thereto as are just. Sanctions applied against claimants may include termination of the claim; or modification of the claim to conform with data provided by the department, information obtained by the court, or information included in an objection. Sanctions applied against objectors and intervenors may include dismissal of the objector or intervenor from the proceeding. Rule 22, W.R.Adj.R.

Sunlight failed to respond to the court's order setting filing deadline. The order stated that it was Sunlight's final chance to file the required evidence and if claimant failed to file evidence by the deadline the objections would be dismissed. Accordingly, Sunlight's objections to its own claims should be dismissed pursuant to Rule 22, W.R.Adj.R.

RECOMMENDATIONS

1. Sunlight's objections to its own claims should be dismissed.
2. The issue remarks should be removed from the claims in this case.

A Post Decree Abstract of Water Right Claim is served with the Report to confirm that the recommended modifications have been made in the state's centralized record system.
