#### **MASTER'S REPORT**

## FINDINGS OF FACT

- 1. Century Ranch, LLC (Century Ranch) is the record owner of claims 39F 145314-00, 39F 145333-00, and 39F 212379-00.
- Claims 39F 145314-00, 39F 145333-00, and 39F 212379-00 were decreed with a variety of DNRC issue remarks. All issue remarks must be addressed.
  - 3. Claim 39F 145314-00 was decreed with the following issue remarks:

THE CLAIMANT DID NOT IDENTIFY THE PERIOD OF DIVERSION FOR THIS RIGHT. A PERIOD OF DIVERSION HAS BEEN ADDED TO MATCH THE PERIOD OF USE. IF NO OBJECTIONS ARE RECEIVED TO THE PERIOD OF DIVERSION OR PERIOD OF USE, THOSE ELEMENTS WILL BE DECREED AS SHOWN ON THIS ABSTRACT AND THIS ISSUE REMARK WILL BE REMOVED FROM THIS CLAIM.

RESERVOIR RECORD WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

POINT OF DIVERSION NO. 2 APPEARS TO BE UNNECESSARY.

The first two issue remarks are notice-type remarks and do not require further attention.


5. Claim 39F 212379-00 is an implied claim, implied from parent claim 39F 145333-00. Claim 39F 212379-00 was decreed with the following issue remark:

NO TYPE OF HISTORICAL RIGHT WAS CLAIMED. DOCUMENTATION TO SUPPORT THE TYPE OF HISTORICAL RIGHT WAS NOT SUBMITTED WITH THIS CLAIM.

Parent claim 39F 145333-00 is a use right, it is common sense that claim 39F 212379-00 is also a use right.

6. An Order was issued setting a deadline for Century Ranch to file a statement indicating whether it agreed or disagreed that the following changes be made to the claims in this Case:

#### • 39F 145314-00:



The Order indicated that if nothing were filed by the deadline, this Master would conclude that the Claimant agrees with the proposed changes. The Order included the following language:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed by the deadline.

### PRINCIPLES AND CONCLUSIONS OF LAW

1. The Water Court is required to address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.

- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just. Century Ranch did not file anything by the deadline set in the May 24, 2022 Order; this Master concludes Century Ranch agrees with the proposed resolution of the issue remarks.
- 4. The period of diversion and reservoir record issue remarks appearing on claim 39F 145314-00 are notice-type issue remarks. As no objections were filed, no further proceedings are required as to the remarks.

## **RECOMMENDATIONS**

- 1. Claims 39F 145314-00, 39F 145333-00, and 39F 212379-00 should be modified as shown in Finding of Fact No. 6.
- 2. The issue remarks should be removed from claims 39F 145314-00, 39F 145333-00, and 39F 212379-00.

Post Decree Abstracts of Water Right Claims are served with the Report for review.
