FINDINGS OF FACT

1. Jerry D. Cathey and Norma A. Cathey are the record owners of claims 39F 145283-00 and 39F 145284-00.

The following issue remarks were decreed on claim 39F 145283-00:

POINT OF DIVERSION AND RESERVOIR RECORD WERE MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

4. A June 24, 2022 deadline was set for Claimants Jerry D. Cathey and Norma A. Cathey to file a statement agreeing or disagreeing with the proposed changes to claims 39F 145283-00 and 39F 145284-00. The Order indicated that if nothing was filed by the deadline, this Master would conclude the Claimants agreed with the proposed changes and a Master's Report recommending the changes would be issued. The Order included the following language:

Failure to comply with the terms of this Order may result in sanctions, up to and including entry of default and termination of a water right claim or dismissal of objections. Rule 22, W.R.Adj.R.

5. Nothing was filed by the deadline.

CONCLUSIONS OF LAW

1. The Water Court is required to address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.

2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

3. The point of diversion and reservoir record issue remarks decreed on claims 39F 145283-00 and 39F 145284-00 are notice-type issue remarks. As no objections were filed, no further proceedings are required.

4. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.
