This Second Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Second Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusion of law, or recommendations. ## SECOND MASTER'S REPORT

## BACKGROUND

A Master's Report was issued in this Case on March 21, 2022. On March 23, 2022, counsel for Claimant and Objector Rocking CB Ranch, LLC ("Rocking CB") objected to the Master's Report requesting a deadline be set to address its self-Objections. The Case was recommitted to the Water Master for the purpose of allowing Rocking CB to address the self-Objections. A deadline was set for Rocking CB to file documentation resolving the self-Objections. On May 5, 2022, Rocking CB filed its Motion for Implied Claim or Incidental Use Remark. The May 5, 2022 filing indicated that granting the requested implied claim resolves Rocking CB's self-objections.

This Second Master's Report is similar to the March 21, 2022 Master's Report in many aspects, but it recommends the creation of an implied claim, resolving Rocking CB's self-Objection. This Second Master's Report supersedes the March 21, 2022 Master's Report.

## FINDINGS OF FACT

- 1. Claims 40A 109952-00, 40A 117445-00, 40A 117464-00, 40A 128573-00, 40A 130890-00, 40A 146673-00, 40A 197890-00, 40A 197964-00, 40A 198165-00, 40A 198287-00, 40A 203568-00, and 40A 30103837 were decreed with an over-filed notice of appropriation issue remark. The remark indicates the claims are based on the June 6, 1926 JB Gregg and Ida Landice filed Notice of Appropriation for 1,000.00 miner's inches (25.00 cubic feet per second (cfs)) from the Mussellshell River.
- 2. Claims 40A 109952-00, 40A 117445-00, 40A 117464-00, 40A 128573-00, 40A 130890-00, 40A 146673-00, 40A 197890-00, 40A 198165-00, 40A 198287-00, and 40A 203568-00 were decreed with the following priority date issue remark:

- 3. Claims 40A 117445-00, 40A 117464-00, 40A 128573-00, 40A 197890-00, 40A 197964-00, 40A 198165-00, 40A 198287-00, and 40A 203568-00 were decreed with DNRC notice-type issue remarks.
- 4. Claim 40A 30103837 was also decreed with the following issue remark that must be addressed:

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. SIMMS DITCH IS LOCATED IN THE NEWSE SEC 2 TWP 6N RGE 19E GOLDEN VALLEY CO.

- 5. Claim 40A 30103837 was also called in on motion of the Court as the wrong version of the abstract was included in the Preliminary Decree, no further action is required as to the on-motion issue.
- 6. Additionally, Rocking CB objected to claims 40A 117445-00 and 40A 117464-00, both of which it owns.
- 7. A deadline was set for the parties to address the issue remarks and Rocking CB Ranch's Objections. The Orders in this Case have included the following language:

  Failure to comply with the terms of this Order may result in sanctions, up to and including entry of default and termination of a water right claim or dismissal of objections. Rule 22, W.R.Adj.R.
- 8. On September 2, 2021, counsel for Alexandra V. Spizziri and John A. Spizziri Sr. filed documentation addressing the issues in this Case. Regarding the point of diversion issue remark decreed on claim 40A 3010387, the filing stated in part:

The Spizziri's agree that the point of diversion be changed from SENWSE of Section 2 6N 19E to NENWSE Section 2 6N19E. Having reviewed the file and specifically the memo from Ed Dobson to Craig Dubois on 9/12/91 wherein it is described as this being a correction section, and having further reviewed this matter with Matt, water resource specialist with DNRC, we agree that there are more accurate ways to plot the location of the point of diversion than there were in 1895. However, we would request a remark be added to the water right claim to the effect. This claim was originally described with the point of diversion being in the SENWSE of Section 2 6N 19E and is further described as such in the Water Resource Survey for Golden Valley County Montana. The change of the point of diversion came about because this was a correction section and DNRC has determined that the newly described point of diversion is a more accurate depiction of what is actually on the ground."

The September 2, 2021 filing also discusses the overclaimed appropriation at issue in this Case, noting that the appropriation accounts for surplus waters.

9. On February 18, 2022, counsel for Rocking CB and Jess Garfield filed a Motion for resolution of the overfiled notice of appropriation issue remark decreed on the claims in this case. Rocking CB and Garfield explain they agree with the Spizziri's September 2, 2021 filing asserting that the Landice Notice of Appropriation was for 25.00 cfs *and* surplus water; the 1.54 cfs claimed over 25.00 cfs reflects the additional surplus water claimed pursuant to the Landice Notice of Appropriation.

The February 18, 2022 filing did not specifically address the status of Rocking CB's Objections.

- 10. A Master's Report was issued on March 21, 2022. Rocking CB objected to the Master's Report, and it was recommitted to this Master. A deadline was set for Rocking CB to file documentation resolving the self-Objections.
- 11. On April 15, 2022, the DNRC updated the ownership of claim 40A 197890-00 to reflect that Rebecca H. Gibbs is the new owner of the claim. The caption and service list for this Second Master's Report has been updated, consistent with the DNRC database.
- 12. On May 5, 2022, Rocking CB filed its Motion for Implied Claim or Incidental Use Remark. The Motion requested the Water Court create an implied claim for stock use from irrigation claims 40A 117445-00 and 40A 117464-00, or alternatively, add an incidental use remark denoting stock use.
- 13. Rocking CB supported the proposed implied claim by noting the Notice of Appropriation for claims 40A 117445-00 and 40A 117464-00 indicates the water is for "irrigation, domestic, and other purposes":

Claims 1000 miners' inches of the waters of musselshell River, and its tributaries in said County and State, for irrigation, domestic and other purposes; place of intended use is to irrigate for agricultural purposes, Lots 9,10,11,12 and 13 of Block 1; Lots 7 and 8 of Block 2 of Parm Addition to Ryegate, Montana and

Rocking CB indicates that stock use is included in "other purposes." Rocking CB also attached the Affidavit of Leonard Schladweiler, who lives on a property neighboring Rocking CB Ranch. Schladweiler is 93 years old and states: "I have a clear recollection of there being stock that watered from ditches on the [Rocking CB] property at various times throughout my life."

## CONCLUSIONS OF LAW

- 1. The Water Court is required to address all issue remarks that appear on a claim as well as any objections claims receive. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. An implied claim is "a claim authorized by the water court to be separated and individually identified when a statement of claim includes multiple rights." Rule 2(a)(33) W.R.C.E.R. Where the DNRC does not identify the implied claim during claim examination and the claimant requests an implied claim, the Water Court applies a three-prong test to determine whether an implied claim is warranted. Water Court Case 76HF-580, *Order Amending and Adopting* at 20 (Jan. 31, 2013):

First, the implied claim must be justified by some evidence in the claim form or the documents attached thereto, although supplemental evidence can be used to explain or clarify the claim and its contents. Second, evidence must exist of actual historic use corroborating the implied claim. Third, the creation of the implied claim should not result in a change to historic water use or increase the historic burden to other water users. The burden to meet these criteria rests on the person seeking recognition of the implied claim.

It is appropriate to generate implied stock claim 40A 30105300 from parent claims 40A 117445-00 and 40A 117464-00.

4. The priority date issue remark decreed on claims 40A 109952-00, 40A 117445-00, 40A 117464-00, 40A 128573-00, 40A 130890-00, 40A 146673-00, 40A 197890-00, 40A 198165-00, 40A 198287-00, and 40A 203568-00 indicated that the claims were not included in Case No. 2248, Golden Valley County. The record does not indicate why the claims were not included in the Case. The only Objections to claims 40A 109952-00, 40A 117445-00, 40A 117464-00, 40A 128573-00, 40A 130890-00, 40A 146673-00, 40A 197890-00, 40A 198165-00, 40A 198287-00, and 40A 203568-00 will

be dismissed (see Recommendation No. 1). The lack of interested objections or notices of intent to appear indicates no interested water users take issue with the priority dates that were decreed on the claims. The priority date issue remark is not supported by evidence sufficient to overcome the prima facie proof afforded the priority dates for the claims. The issue remark has provided notice to claimants and other water users, and the remark can be removed from claims 40A 109952-00, 40A 117445-00, 40A 117464-00, 40A 128573-00, 40A 130890-00, 40A 146673-00, 40A 197890-00, 40A 198165-00, 40A 198287-00, and 40A 203568-00.

5. The point of diversion issue remark decreed on claims 40A 117445-00, 40A 117464-00, 40A 128573-00, 40A 197890-00, 40A 197964-00, 40A 198165-00, 40A 198287-00, and 40A 203568-00 is a notice-type issue remark. The only objections filed in this Case were to claims 40A 117445-00 and 40A 117464-00 and those Objections have been resolved with the generation of implied claim 40A 30105300. No further proceedings are required.

## RECOMMENDATIONS

- 1. Implied claim 40A 30105300 should be generated, representing the stock use described on Statements of Claims 40A 117445-00 and 40A 117464-00. A Post Decree Abstract for claim 40A 30105300 is attached to this Report.
- 2. The point of diversion of claim 40A 30103837 should be modified as follows:

And the following information remark should be added, as requested by the Claimant:

THIS CLAIM WAS ORIGINALLY DESCRIBED WITH THE POINT OF DIVERSION BEING IN THE SENWSE OF SECTION 2, 6N, R19E, GOLDEN COUNTY. THE POINT OF DIVERSION LEGAL LAND DESCRIPTION CHANGE CAME ABOUT BECAUSE THIS IS A CORRECTION SECTION AND DNRC DETERMINED THE NEWLY DESCRIBED POINT OF DIVERSION LEGAL LAND DESCRIPTION MORE ACCURATELY DESCRIBES WHAT IS ACTUALLY ON THE GROUND.
