## ORDER AMENDING AND ADOPTING MASTER'S REPORT

Pursuant to Montana Code Annotated, Section 85-2-233(5), Case 40E-0028-R-2022 was assigned to Water Master Eyvind Ostrem. The Water Master filed a Report containing Findings of Fact and Conclusions of Law with the Clerk of Court. Copies of the Report were served on the parties June 9, 2022. On June 17, 2022, claimant Horse Ranch Inc. filed an Objection to Master's Report to Correct Clerical Mistake.

Horse Ranch Inc. points out that the Master's Report and attached abstracts contained a clerical error in the informational remark it sought to add to the claims. Specifically, the word "use" was omitted from the phrase "irrigate the place of <u>use</u> with a system of dikes." Horse Ranch therefore requests that the abstracts be corrected in the Court's adoption of the master's report. The time frame for filing objections has elapsed and no other objections to the Findings and Conclusion have been filed.

The abstracts are corrected to resolve the clerical error and objection to the Master's Report. No other amendments to the June 9, 2022 Master's Report are needed.

Pursuant to Rule 53(e), Montana Rules of Civil Procedure, the Court **ADOPTS** the Master's Report and its Recommendations with the above-referenced amendments, and **APPROVES** the changes to the centralized computer record system that are reflected on each abstract served with this order.
