This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy

of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

## **MASTER'S REPORT**

### **FINDINGS OF FACT**

1. The above-captioned claims appeared in the Preliminary Decree for Box Elder Creek (Basin 39E) with issue remarks.
2. On March 25, 2022, the above-captioned claims were consolidated into Water Court Case 39E-0125-R-2022 and the claimants were ordered to work with the Department of Natural Resources and Conservation (DNRC) to resolve the issue remarks on the claims.
3. On June 22, 2022, the DNRC filed a Memorandum detailing several proposed modifications to the claims that would resolve the issue remarks. The Memo stated that the claimants had failed to contact the DNRC as ordered.
4. The Memo stated that the DNRC was able to locate the claimed reservoir for claim 39E 121699-00 and recommended that the reservoir issue remark be removed and that the means of diversion be modified to 'Dam'. Pursuant to the Order and the Memo, the claim should be modified accordingly.
5. The Memo stated that the place of use for claim 39E 121700-00 should be modified to the SENESW S24 T6S R56E and that adoption of the modification would resolve the issue remark. Pursuant to the Order and the Memo, the claim should be modified accordingly.
6. The Memo stated that the DNRC was able to locate the reservoir for claim 39E 121709-00 and recommended that the reservoir issue remark be removed and that the claim be modified as follows:

7. The Memo stated that DNRC was unable to locate a reservoir in the claimed location for claim 39E 121712-00. The Memo further stated that the claimed reservoir appears to have been washed out sometime between 1944 and 1980 and is still washed out in the 2017 aerial photograph. Accordingly, the reservoir record for the claim should be removed. Removal of the reservoir record resolves the issue remark.

8. The Memo stated that DNRC was unable to locate the reservoir associated with claim 39E 121716-00 in any aerial photograph they reviewed. Accordingly, the reservoir record for the claim should be removed and a point of diversion should be added in the NWSESW of S24 T6S R56E Carter County pursuant to the standards associated with livestock drinking directly from the source.

9. The Memo stated that claim 39E 121727-00 listed two locations as “nonpoint” specific on the original claim form, the means of diversion as natural flooding and the means of conveyance as natural overland flow. The Memo goes on to state that the claim appears to be natural overflow water right.

10. Claim 39E 121727-00 was previously adjudicated in Water Court Case 39E-74 during the Temporary Preliminary Decree on Motion of the Montana Water Court. The Master’s Report from the Case stated that the flow rate does not require change. The narrative description of the flow rate states that the claim consists of direct flow water spreading. As the flow rate has already been affirmatively adjudicated by this Court and implicitly describes the claim’s type of right, this Master declines to implement the DNRC’s proposed suggestion at this time. While it may appear that the means of

diversion and type of right are in conflict, a finding of fact has already been made in regards to the irrigation type. Accordingly, the issue remark should be removed from the claim.

11. The remaining remarks are notice-type remarks that have served their purpose and should be removed from the claims.

### **PRINCIPLES OF LAW**

1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(12), MCA.

2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.

### **CONCLUSIONS OF LAW**

1. The claims should be modified as discussed above. Modification of the claims resolves the issue remarks discussed in the March 25, 2022 Order.

2. The remaining issue remarks are notice type remarks that have served their purpose and should be removed from the claims.

### **RECOMMENDATION**

1. Upon review the record in this case, the above-captioned claims should be modified as discussed above. The issue remarks should be removed from the claims.
