
FINDINGS OF FACT

- Allen Elmore claim 39E 30139040 was decreed with DNRC issue remarks: THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 39E DECREE ISSUED 02/01/1985.
 NO QUANTIFIED FLOW RATE HAS BEEN CLAIMED.
- 2. All DNRC issue remarks must be resolved.

- 3. The first issue remark decreed on claim 39E 30139040 explains that the claim was not part of the first decree issued in Basin 39E. It is a notice-type issue remark and does not require further attention.
- 4. The second issue remark points to the 2019 Statement of Claim form filed for claim 39E 30139040. The portion of the claim where flow rate was to be indicated was left blank:

A Declaration of Vested Groundwater Rights was attached to the Statement of Claim, and it described the historical water right, including the flow rate of the claim:



Based on the record, it appears the flow rate for claim 39E 30139040 should be 20.00 gallons per minute.

5. An Order was issued setting a deadline for Claimant Allen Elmore to file a statement agreeing or disagreeing that a 20.00 gallon per minute flow rate be added to claim 39E 30139040. The Order indicated that if nothing were filed by the November 4, 2022 deadline, this Master would conclude Allen Elmore agrees the flow rate for claim 39E 30139040 is 20.00 gallons per minute. The following language was included in the Order:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 2. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.
- 3. The remark indicating claim 39E 30139040 was not included in the first decree in this Basin is a notice-type issue remark. As no objection was filed, no further proceedings are required.

RECOMMENDATIONS

- 1. The flow rate for claim 39E 30139040 should be 20.00 gallons per minute.
- 2. The issue remarks should be removed from the claim.
