MASTER'S REPORT

FINDINGS OF FACT

- 1. LO Ranch Limited Partnership (LO Ranch) is the record owner of claims 39F 123230-00, 39F 123241-00, and 39F 123270-00.
- 2. Claims 39F 123230-00, 39F 123241-00, and 39F 123270-00 were decreed with DNRC issue remarks:

Claim 39F 123230-00:

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OF THE PLACE OF USE APPEARS TO BE ON PROPERTY OWNED BY THE BUREAU OF LAND MANAGMENT.

THE CLAIMANT DID NOT IDENTIFY THE PERIOD OF DIVERSION FOR THIS RIGHT. A PERIOD OF DIVERSION HAS BEEN ADDED TO MATCH THE PERIOD OF USE. IF NO OBJECTIONS ARE RECEIVED TO THE PERIOD OF DIVERSION OR PERIOD OF USE, THOSE ELEMENTS WILL BE DECREED AS SHOWN ON THIS ABSTRACT AND THIS ISSUE REMARK WILL BE REMOVED FROM THIS CLAIM.

THE CLAIMED VOLUME APPEARS TO BE EXCESSIVE FOR THE CLAIMED PURPOSE. THE CLAIMED VOLUME EQUALS 154 TIMES THE CAPACITY OF THE RESERVOIR.

Claim 39F 123241-00:

THE CLAIMANT DID NOT IDENTIFY THE PERIOD OF DIVERSION FOR THIS RIGHT. A PERIOD OF DIVERSION HAS BEEN ADDED TO MATCH THE PERIOD OF USE. IF NO OBJECTIONS ARE RECEIVED TO THE PERIOD OF DIVERSION OR PERIOD OF USE, THOSE ELEMENTS WILL BE DECREED AS SHOWN ON THIS ABSTRACT AND THIS ISSUE REMARK WILL BE REMOVED FROM THIS CLAIM.

RESERVOIR RECORD WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

THE CLAIMED VOLUME APPEARS TO BE EXCESSIVE FOR THE CLAIMED PURPOSE. THE CLAIMED VOLUME EQUALS 28.4 TIMES THE CAPACITY OF THE RESERVOIR.

Claim 39F 123270-00:

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OF THE PLACE OF USE APPEARS TO BE ON THE BUREAU OF LAND MANAGEMENT.

- 3. The United States of America (Bureau of Land Management) objected to claims 39F 123230-00 and 39F 123241-00.
- 4. On October 21, 2022, the parties filed a Stipulation resolving the Objections to claims 39F 123230-00 and 39F 123241-00, a copy of the Stipulation is attached.
- 5. Pursuant to the Stipulation, the following changes should be made to claims 39F 123230-00 and 39F 123241-00:

6. Claims 39F 123230-00 and 39F 123241-00 are water spreading claims and both claims were decreed excessive volume issue remarks. The excessive volume issue remarks ignore the fact that the claims do not use the water stored in a reservoir but rather the water that *exceeds* the storage capacity of the reservoir. The storage capacity of the reservoir is not the correct guideline or limitation for determining the reasonableness of the claimed volume.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court is required to address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. The volume guideline applicable to direct flow water-spreading systems that do not utilize stored water is the number of acre-feet per acre based upon the climatic area for the claimed place of use. *See* Rule 15(b),(c),(e), W.R.C.E.R. The claimed place of use for claims 39F 123230-00 and 39F 123241-00 is in climatic area II. The guideline for climatic area II is 2.00-acre feet per acre. Nevertheless, the guideline is simply a guideline and not a limitation on a water right and the guideline does not overcome the prima facie statement of claim, the volume issue remarks can be removed.

4. The period of diversion and reservoir record issue remarks decreed on claims 39F 123230-00 and 39F 123241-00 are notice-type issue remarks. As the Objections in this Case have been resolved, no further proceedings are required.

RECOMMENDATIONS

- 1. Claims 39F 123230-00 and 39F 123241-00 should be modified as shown in Finding of Fact No. 5.
 - 2. The issue remarks should be removed from the claims in this Case.

STIPULATION TO RESOLVE OBJECTIONS

This Stipulation, entered into by the United States of America, Bureau of Land Management (the "United States"), and Claimant LO Ranch Limited Partnership ("Claimant"), is for the purpose of resolving the United States' objections to Water Right Claim Nos. 39F 123230-00 and 39F 123241-00.

RECITALS

- A. Pursuant to Mont. Code Ann. § 85-2-221, Claimant, or a predecessor-in-interest to Claimant, timely filed Statements of Claim for claims 39F 123230-00, 39F 123241-00, and 39F 123270-00 with the Department of Natural Resources and Conservation.
- B. Pursuant to Mont. Code Ann. § 85-2-233, the United States timely filed Notices of Objection to claims 39F 123230-00 and 39F 123241-00 as they appeared on the Preliminary Decree for Basin 39F.
- C. Claim 39F 123230-00 asserts a use right on an Unnamed Tributary of South Butte Creek for irrigation of a maximum of 40 acres. As described on the Preliminary Decree for Basin 39F, the legal land description for the place of use is overbroad and inaccurately includes federal lands. Clarification of the legal land description will more accurately reflect current and historical use.
- D. Claim 39F 123241-00 asserts a use right on an Unnamed Tributary of South Butte Creek for irrigation of Claimant's place of use for a maximum of 40 acres. As described on the Preliminary Decree for Basin 39F, the legal land description for the place of use is overbroad and inaccurately includes federal lands. Clarification of the legal land description will more accurately reflect current and historical use.
- E. In the interest of resolving this case without the need for further litigation, Claimant and the United States stipulate to the modifications below.

Upon entry of a ruling and final order in this case reflecting the amendments specified above for claims 39F 123230-00 and 39F 123241-00, the United States' objections to claims 39F 123230-00 and 39F 123241-00 shall be deemed resolved, provided that such order(s) do not expand or change other substantive elements of the claims.

- 5. This Stipulation is the compromise of disputed water claims and is not to be construed as an admission against the interests of any party.
- 6. The terms of this Stipulation are binding on the parties, their successors, and assignees. Nothing in this Stipulation shall create any right, claim, cause of action, objection, defense, or other remedy in any person not a party to the Stipulation.
- 7. Each party will bear its own costs and attorney fees arising from the negotiation and execution of the Stipulation and in proceedings before the Montana Water Court regarding this case.
- 8. Each undersigned party entered into and executed this Stipulation voluntarily, in good faith, and without any fraud, misunderstanding, misrepresentation, overreaching, duress, or undue influence, whatsoever.
- 9. The parties hereto represent and affirm that the signatories to this Stipulation are legally authorized to bind the party to this matter.
- 10. This Stipulation may be executed by the parties in counterparts, each of which when executed and filed with the Montana Water Court shall be an original, but all of which together shall constitute one instrument.
- 11. This document (\P 1-11) embodies the entire Stipulation of the parties. IT IS SO STIPULATED on the date last entered below:


