THE TYPE OF HISTORICAL RIGHT, PRIORITY DATE, AND FLOW RATE MAY BE QUESTIONABLE. THE CLAIMS FOLLOWING THIS STATEMENT USE THE SAME FILED APPROPRIATION TO DOCUMENT THE RIGHT. THE COMBINED FLOW RATE FOR THIS GROUP OF CLAIMS EXCEEDS THE TOTAL OF THE ORIGINAL APPROPRIATION. 39F 211107-00. 39F 211108-00.

THE PRIORITY DATE MAY BE QUESTIONABLE. THE SOURCE DESCRIBED ON THE FILED NOTICE OF APPROPRIATION IS INCONSISTENT WITH THE CLAIMED SOURCE.

48. Ms. Norris recounted her review of the system described by claims 39F 211107-00 and 39F 211108-00 in her October 3, 2022 Declaration, at 68:

I have been unable to locate a copy of the referenced appropriation to review the document further. The field notes also indicate "no irrigation." This may be because when the area was field surveyed in September 1958, no active irrigation was observed. This is not surprising. Water spreading systems are designed to operate whenever high runoff events occur, typically in the spring or during significant rainstorm events. The area was field surveyed in the fall, when runoff events are infrequent and, if they do occur, may not result in enough water for the water spreading system to fully operate. The oldest aerial photographs I could find of the area the water spreading systems are located in were taken in 1972 and 1979. Although the photographs do not capture the system in its entirety, most of the system can be Seen and dikes can be observed throughout the places of use. The dikes are intact and capable of diverting runoff water whenever it occurs.

49. The BLM requests that claims 39F 211107-00 and 39F 211108-00 be modified to "use" rights with August 5, 1972 priority dates.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court is required to address all issue remarks that appear on a claim as well as any objections a claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

- 3. An August 7, 1987 Order signed by Chief Water Judge W.W. Lessley ordered DNRC to include the claimed volume for all stock water reservoir and pothole lake claims owned by the United States of America.
- 4. Place of use was not on the objection list for claim 39F 61473-00, point of diversion/means of diversion was not on the objection list for claim 39F 61566-00, and source was not on the objection list for claims 39F 61772-00 and 39F 61773-00, place of use was not on the objection for claim 39F 61866-00 and therefore, other water users failed to receive notice that the elements may be modified. Accordingly, the Bureau of Land Management's proposed modifications are deemed motions to amend.

Regarding claim 39F 61473-00, the Bureau of Land Management owns the entirety of the legal land description where the claimed and modified point of diversion is located, and no other water users have places of use between the claimed and modified legal land descriptions. The modification to claim 39F 61566-00 is simply providing accurate measurements for the existing reservoir. The place of use legal land description change for claim 39F 61866-00 modifies the place of use to match the point of diversion – owned by the BLM. These changes do not have the ability to adversely affect other water users and no public notice of the amendments is necessary.

However, the source change for claims 39F 61772-00 and 39F 61773-00 could impact other water users. The claims will be removed from this Case and reconsolidated for further proceedings.

5. The notice-type issue remarks decreed on many of the claims in this Case have served their notice purpose. As no objections were filed, no further proceedings are required.

RECOMMENDATIONS

- 1. The proposed changes to claims 39F 61772-0 and 39F 61773-00 should not be made at this time. Claims 39F 61772-00 and 39F 61773-00 have been removed from this Case and they have been reconsolidated for further proceedings.
 - 2. The October 3, 2022 filing included requests to make changes to elements

of claims that were not on the objection list or were not owned by the BLM. This Water Master made the changes wherever feasible; however, in the future, the BLM should more carefully review the decree and object where appropriate.
