MASTER'S REPORT

FINDINGS OF FACT

1. Henry Guth, Inc. (Guth) is the owner of claims 43A 23725-00, 43A 23730-00, 43A 23731-00, and 43A 191258-00.

2. Claim 43A 23725-00 was decreed with a notice-type issue remark. Claim 43A 191258-00 was decreed with a point of diversion issue remark.

3. The United States of America (Bureau of Reclamation) (hereinafter "BLM") objected to claims 43A 23725-00, 43A 23730-00, 43A 23731-00, and 43A 191258-00. Cindy Zimmerman and Ned Zimmerman (the Zimmermans) objected to claim 43A 191258-00.

4. The parties in Case 43A-0332-R-2020 requested a mediator, and after mediation the parties filed a Stipulation to Resolve Objections on May 19, 2022 (Stipulation).

5. The Stipulation indicated claim 43A 23725-00 should be dismissed, and proposed changes to claims 43A 23730-00, 43A 23731-00, and 43A 191258-00, including the generation of three implied claims.

6. This Water Master had concerns regarding the proposed implied claims, and deadlines were set for the parties to respond to the concerns.

7. Additionally, as recently as the September 19, 2022 filings in the Case, this Master noted that there appeared to be a misunderstanding between the parties, or between Guth/Zimmerman and Guth/Zimmerman's counsel regarding whether the implied claims should have a quantified volume.

8. In an effort to resolve the outstanding issues, this Master explained:

This Master also notes that her concerns in the Case would be resolved if the proposed implied claims were changed from "use" rights to "decreed" rights and the volumes for the proposed implied claims were changed from quantified volumes to the standardized remark: "THE TOTAL VOLUME OF THIS WATER RIGHT SHALL NOT EXCEED THE AMOUNT PUT AT HISTORICAL AND BENEFICIAL USE." This Master agrees with the parties that overall, the parties are proposing reductions of the claims, even with the addition of the proposed implied claims. However, the parties have not shown existence of use rights present in the Statements of Claim or documents

attached thereto – but the existence of implied wastewater claims appear to be an inherent part of the claims.

September 21, 2022 *Order on Status of Case, Order Denying Motion for Status Conference, and Order Setting Filing Deadline.* A deadline was set for the parties to agree or disagree with the modifications as proposed by this Master. On September 22, 2022 the BOR filed a Statement indicating that the Stipulation should be modified as suggested by this Master. On October 17, 2022, Guth and the Zimmermans filed a Response indicating they agree with “the provisions of the Order proposing to adopt the Stipulation, with the recommended modifications....”

PRINCIPLES AND CONCLUSIONS OF LAW

1. The Water Court must address all issue remarks that appear on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.

2. A properly filed Statement of Claim for an existing water right is *prima facie* proof of its content. Section 85-2-227, MCA. This *prima facie* validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

3. The Water Court is not bound by settlement agreements. Settlement agreements are subject to review and approval by the Water Court. Rule 17, W.R.Adj.R. The Stipulation is a settlement agreement subject to such review.

4. An implied claim is “a claim authorized by the water court to be separated and individually identified when a statement of claim includes multiple rights.” Rule 2(a)(33) W.R.C.E.R. In the present case, it is appropriate to imply wastewater claims 43A 20155755, 43A 30155756, and 43A 31055757.

RECOMMENDATIONS

1. Claim 43A 23725-00 should be dismissed.

2. Claims 43A 23730-00, 43A 23731-00, and 43A 191258-00 should be modified as described in the Findings of Fact and attached Post Decree Abstracts. The issue remark should be removed from claim 43A 191258-00.

3. Claims 43A 30155755, 43A 30155756, and 43A 30155757 should be generated as shown in the Findings of Fact and attached Post Decree Abstracts.
