#### **MASTER'S REPORT**

#### Statement of the case

Cornwell Ranch stock claim 40N 30138116 received the following issue remarks:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 40N DECREE ISSUED 08/13/1985.

ACCORDING TO CADASTRAL PROPERTY OWNERSHIP RECORDS, AS OF 11/18/2019, A PORTION OF THE PROPERTY ON WHICH THIS WATER RIGHT IS USED APPEARS TO BE OWNED BY STATE OF MONTANA SCHOOL TRUST LANDS.

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT WERE FILED BY DIFFERENT PARTIES WHO CLAIM OVERLAPPING PLACES OF USE. 40N 30143033, 40N 30138116.

IT IS UNCLEAR IF THIS CLAIM IS CLAIMING A RESERVOIR. THE RESERVOIRS ARE LOCATED IN NEW SEC 16 T34N R39E AND NWSENW SEC32 T34N R38E.

THIS CLAIM APPEARS TO BE CLAIMING THREE SEPARATE SOURCES OF WATER. MORE THAN ONE WATER RIGHT MAY BE INVOLVED.

United States of America (Bureau of Land Management) stock claim 40N 30143033 received the following issue remarks:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 40N DECREE ISSUED 08/13/1985.

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT WERE FILED BY DIFFERENT PARTIES WHO CLAIM OVERLAPPING PLACES OF USE. 40N 30143033 & 40N 30138116.

Issue remarks result from Department of Natural Resources and Conservation ("DNRC") claims examination. Claims examination confirms the historical use of water right claims and identifies issues with claims. If claims examination cannot confirm some aspect of a claim, an issue remark is added to the claim. Montana law requires the Water Court to resolve issue remarks.

Stock claim 40N 30138116 received a notice of intent to appear from claimant, Cornwell Ranch stating, "This claim has DNRC issue remarks, and resolution of these issue remarks may change or alter elements of the water right."

On May 24, 2022, Cornwell Ranch filed its Response to Request for Evidence,

Motion to Amend, and Request for Implied Claims ("Response").

On June 28, 2022, the United States of America (Bureau of Land Management) filed its Response to Court Order ("Response").

All elements appeared on the Basin 40N objection list for claim 40N 30138116.

#### **Issues**

- 1. Are the issue remarks on the claims resolved?
- 2. Is Cornwell Ranch's notice of intent to appear resolved?

## Findings of fact

- 1. Cornwell Ranch confirms the historical accuracy of prima facie statement of claim 40N 30138116. Stock do not use stored water, only water directly from the claimed sources.
  - 2. Claim 40N 30138116 is an exempt claim pursuant to Section 85-2-222, MCA.
- 3. Statement of claim 40N 30138116 claimed Chisholm Creek and unnamed tributaries as its source and livestock direct from source as it means of diversion. A map attached to the statement of claim depicts the locations and sources from which the livestock drink.
- 4. The Preliminary Decree abstract for claim 40N 30138116 identifies Chisholm Creek and Unnamed Tributaries of Chisholm Creek, Long Coulee, and an Unnamed Tributary of Bitter Creek as sources.
- 5. Three implied claims, for the additional sources other than Chisholm Creek, should be generated from claim 40N 30138116.
- 6. The Preliminary Decree abstract for claim 40N 30143033 accurately reflects historical use.

## Principles of law

1. A properly filed Statement of Claim for Existing Water Right or an amended claim for Existing Water Right is prima facie proof of its content. Section 85-2-227,

- MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that an element of the prima facie claim is incorrect. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R. A preponderance of the evidence is a "modest standard" and is evidence that demonstrates the fact to be proved is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 348, 240 P.3d 628.
- 2. The Montana Water Court is permitted to use information submitted by the Department of Natural Resources and Conservation, the statement of claim, information from approved compacts, and any other data obtained by the Court to evaluate water right claims. Section 85-2-231(2), MCA.
- 3. Settlement, including the documents filed by a claimant where the claimant is the only party, is subject to review and approval by the Water Court. Rule 17(a), W.R.Adj.R.
- 4. The Montana Water Court shall request additional evidence if the settlement agreement expands or enlarges an element of a claim and the burden of proof is not met. If additional evidence does not meet the burden of proof, the element shall not be expanded or enlarged. Rule 17(b), W.R.Adj.R.
- 5. The Montana Water Court may accept a settlement agreement that reduces or limits an element of a claim and need not determine whether the burden of proof is met unless there is an unresolved issue remark on the claim. Rule 17(c), W.R.Adj.R.
- 6. When resolving issue remarks, the Montana Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA.
- 7. The Montana Water Court has the authority to resolve issue remarks when the claim file and information available to the Court provide a sufficient basis to do so. Section 85-2-248(3), MCA.
- 8. The Water Court has acknowledged its authority to generate implied claims during adjudication. *Bergin v. Nelson*, Case 40C-47 at p. 16, (MT Water Court Memorandum Opinion Feb. 21, 2001); *See* Rule 35, W.R.C.E.R. If a statement of claim

was timely filed, and the form contains multiple rights, the statutory deadline set by § 85-2-221, MCA has been met for the multiple rights. *Bergin* at p. 16.

- 9. Pursuant to *Eliasson Ranch Company v. Rodeghiero*, Case 40A-115 at p. 4-5, (MT Water Court Order Amending and Adopting Master's Report Jun. 28, 2004). When generating an implied claim the following guidelines apply.
  - An implied claim may be generated based only on the attachments to a statement of claim, but typically it is based on the statement of claim itself.
  - There is usually evidence of two or more claims on the face of the statement of claim, most commonly indicated by an overstatement of an element, or the identification of multiple purposes, multiple priority dates, or multiple sources.
  - The generation of an implied claim must come from the statement of claim as originally filed.

"A statement of claim cannot be amended after the filing deadline or changed through the objection process to expand the elements of the filed statement of claim and thereby create the groundwork to add additional water rights through the implied claim process. The implied claim process cannot be used to circumvent the claim filing process in order to cure a failure to file a water right claim in a timely fashion. That practice would be contrary to the late claim provisions of the statutes." Section 85-2-221 and 85-2-225, MCA. *Adjudication of Water Rights of Yellowstone River*, 253 Mont. 167, 832 P.2d 1210 (1992) (emphasis added).

- 10. Foss v. Van Arsdale, Case 76HF-580 at p. 20, 23, (MT Water Court Order Amending and Partially Adopting Master's Report as Amended Jan. 31, 2013), added an additional layer of review to the above analysis for generating implied claims. Three criteria must be met by the party requesting an implied claim.
  - Evidence corroborating the actual historic use of the implied claim must exist.
  - Supplemental evidence that <u>explains or clarifies</u> the statement of

claim may be considered.

• The creation of an implied claim should not change the historic use of water or increase the historic burden on other water users.

If these criteria are not met, water rights are lost even when "ample evidence of historic use otherwise exists" thereby establishing "an appropriate balance between recognition of legitimate claims and upholding the substance of the forfeiture statute." Section 85-2-226, MCA.

- 11. "Existing right' or 'existing water right' means a right to the use of water that would be protected under the law as it existed prior to July 1, 1973." Section 85-2-102(13), MCA
- 12. Exempt rights are existing rights for stock or domestic use of groundwater or instream flow. Section 85-2-222(1), MCA.
- 13. "The first in time is the first in right, and multiple persons may therefore perfect claims to water from the same source as is the case across the breadth of our State." *BLM v. Barthelmess Ranch Corp.*, 2016 MT 348, ¶ 39, 386 Mont. 121, 133, 386 P.3d 952, 961.

## **Analysis**

## Resolution of issue remarks and notice of intent to appear

An ownership issue remark provided notice to potential owner, the State of Montana Board of Land Commissioners, that it may have an ownership interest in claim 40N 30138116. The State of Montana was given the opportunity to review the claim and file an objection. The deadline to file objections has expired. The State of Montana did not file an objection to the claim.

The map attached to statement of claim 40N 30138116 depicts multiple sources. The statement of claim claimed Chisholm Creek and unnamed tributaries. The identification of multiple sources on the same statement of claim, indicates multiple rights within the same filing, one for each named source. The prima facie statement of claim and the map attached to the statement of claim provide the requisite evidence

corroborating the actual historic use of the implied stock claims requested by Cornwell Ranch. Three implied claims should be generated - one for an Unnamed Tributary of Chisholm Creek, one for Bitter Creek and an Unnamed Tributary of Bitter Creek, and one for Long Coulee and an Unnamed Tributary of Long Coulee. The generation of the implied stock claims will not increase the historic burden on the source.

While DNRC claims examination identified reservoirs within the claimed place of use legal land descriptions, the map attached to statement of claim 40N 30138116 did not include reservoirs within the place of use legal land descriptions, and the statement of claim identified the means of diversion as stock drinking directly from the claimed sources, not stored water from reservoirs. Furthermore, a statement by Lee Cornwell, President of Cornwell Ranch attached to statement of claim 40N 30138116 states that, "Cornwell Ranch cattle water from this source [Chisholm Creek and its unnamed tributaries]...the practice predecessors of Cornwell Ranch employed...." The statement makes clear that the claim does not include stored water from reservoirs. Finally, Cornwell Ranch's Response confirms that stock drink directly from the sources, not from reservoirs, and confirms the historical accuracy of the prima facie statement of claim.

Based on the foregoing, Cornwell Ranch stock claim 40N 30138116 is an existing right for instream flow. United States of America (Bureau of Land Management) stock claim 40N 30143033 is also an existing right for instream flow. The claims meet the definition of an "exempt claim." Section 85-2-222(1), MCA. In 2013 and 2017, the Montana Legislature amended § 85-2-222, MCA, and provided for the filing of exempt claims subject to specified terms and conditions. The claims are timely filed exempt claims. The claims appeared in the Preliminary Decree with the following issue remark:

CLAIM WAS NOT INCLUDED IN THE BASIN 40N PRELIMINARY DECREE ISSUED 08/13/85.

Water users were given the opportunity to review the claims and file an objection. The deadline to file objections has expired. No objections were filed against the claims.

Cornwell Ranch's Response and the United States of America (Bureau of Land Management's) Response both agree that their claims have overlapping places of use. Both parties cite to *BLM v. Barthelmess Ranch Corp.*, 2016 MT 348, 386 Mont. 121, 386

P.3d 952, where the Montana Supreme Court held that Montana water law has long recognized the appropriation of water by different parties from the same source, and specifically that a private appropriator and the United States of America (Bureau of Land Management) can have an appropriation from the same source. Both Cornwell Ranch and the United States of America (Bureau of Land Management) may claim the same source. When the appropriations are for livestock direct from source, it necessarily results in overlapping places of use because the place of use is the source. There is no issue to resolve.

#### **Conclusions of law**

The issue remark concerning potential ownership by the State of Montana, appearing on claim 40N 30138116, served its notice purpose.

Generation of the implied claims resolves the issue remark on claim 40N 30138116 concerning three separate sources and the possibility that more than one water right may be involved.

Evidence in the claim file and the prima facie proof afforded stock statement of claim 40N 30138116 confirm the claim is an existing stock right for instream flow. Claim 40N 30138116 meets the definition of an exempt right. The issue remark questioning whether the claim includes reservoirs does not outweigh the prima facie proof afforded the statement of claim. The issue remark is resolved.

The issue remark concerning lack of the claims' inclusion in the previous decree served its notice purpose.

The overlapping place of use issue remark appearing on the claims does not raise a valid issue that requires resolution by the court.

All concerns raised by Cornwell Ranch's notice of intent to appear are resolved.

#### Recommendations

Claim 40N 30138116 should be modified as follows to accurately reflect historical use.
