NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusion of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

All water right claims that appeared in the Preliminary Decree for Sun River (Basin 41K) were subject to "issue remarks" resulting from pre-decree examination by the DNRC, objections, and counterobjections. Claims 41K 131427-00 and 41K 131428-00 each received issue remarks during the DNRC's review of the claims.

The claims were consolidated into Case 41K-0622-R-2023 and an Order Setting Filing Deadline was issued by the Water Court requesting any additional information needed to resolve the duplicate filing issue remarks.

FINDINGS OF FACT

1. Each of the claims received the following substantive issue remark:

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED. 41K 131427-00, 41K 131428-00.

2. On July 18, 2023, the Water Court consolidated the claims and issued an Order setting Filing Deadline explaining that it did not appear the claims duplicated one another. The Order Setting Filing Deadline included the following language regarding the above-listed issue remark:

ORDERED that the Claimant review this order and, *if necessary*, file information or evidence disputing the proposed modification of the type of right for claim 41K 131428-00 from “use” to “filed” by **Wednesday, August 16, 2023**.

If nothing is filed by the ordered deadline, this Master will conclude that the Claimant agrees that the type of historical right for claim 41K 131428-00 should be modified as described above, and the issue remarks will be removed from the claims.

Nothing was filed by the ordered deadline.

3. Each claim also received notice-type issue remarks stating that part of the place of use was also claimed by the record owner of claim 41K 96362-00 and that the point of diversion and ditch name of each claim was modified by the DNRC during its claims reexamination. No objections were filed.

PRINCIPLES OF LAW

1. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
2. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

3. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the *prima facie* status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

CONCLUSIONS OF LAW

1. The information in the record resolves issue remarks appearing on claims 41K 131427-00 and 41K 131428-00. Because nothing was filed at the filing deadline by the Claimant, the type of historical right for claim 41K 131428-00 should be changed from “use” to “filed” and the duplicate filing issue remarks should be removed from the claims.

2. The notice-type issue remarks appearing on claims 41K 131427-00 and 41K 131428-00 served their notice purpose and should be removed from the claims.

RECOMMENDATIONS

The type of historical right for claim 41K 131428-00 should be changed from “use” to “filed” and issue remarks should be removed from the claims.

Post decree abstracts of the water right claims reflecting the recommended changes are attached to this Report.
