MASTER'S REPORT

FINDINGS OF FACT

- 1. Dearborn Canal Co. is the current record owner of claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00.
- 2. Claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 were decreed with notice-type issue remarks.
- 3. Dearborn Canal and Water Co. (DCWC) objected to claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00, stating:

The correct name of the Company is Dearborn Canal and Water Company and ownership should be updated accordingly. The Company's name was incorrectly shortened during Basin 41U TPD proceedings. The Company's place of use should be decreed as a service area with a maximum acreage limit for the irrigation season because the Company is a water supply company that was formed to sell water to shareholders whose lands were susceptible to irrigation.

- 4. Regarding the ownership portion of the Objections, upon review of the record, it is unclear where the name error was initiated; as this Water Master explained in the Order Consolidating, the ownership of claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 will be corrected in this Order. From here forward, both the Claimant and the Objector will be referred to as DCWC. The ownership of claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 has been corrected on the attached Post Decree Abstracts and in the caption of the Report.
- 5. Notices of Intent to Appear were filed by Wolf Creek Ranch, LLC, SKC Minerals, LLC, and Dearborn Ranch, LLC for each of claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00.

Wolf Creek Ranch, LLC withdrew its Notices of Intent to Appear on May 15, 2023. (Doc. 12.00).

6. On September 29, 2023, DCWC filed an Unopposed Motion for Summary Judgment and Brief in Support along with Affidavits. (Docs. 7 through 10). The

September 29, 2023 Motion was unopposed, no ruling is needed, and together the September 29, 2023 filings will be referred to as "the Settlement."

- 7. The record shows that the Dearborn Canal appeared on a GLO plat for Township 18 North, Range 7 West on July 28, 1892. (Doc. 10.00). DCWC was incorporated on May 29, 1913 for the following purposes:
 - To purchase or otherwise acquire, construct, own, hold, use and operate canals, canal systems, laterals, flumes, reservoirs, dams, ditches and rights of way therefor for supplying water and for the irrigation of lands.
 - To purchase or otherwise acquire, own, hold, use, sell, convey or otherwise dispose of water, water rights and flowing streams.
 - To purchase or otherwise acquire, own, hold, rent, use, lease, sell, convey or otherwise dispose of rights to the use of streams and other bodies of water, and to appropriate water for use, lease or sale.
 - To purchase, hold, develop, use, lease, sell, convey or otherwise dispose of water, powers and the sites therefor and lands necessary or useful therefor.
 - To acquire by purchase or otherwise, own, rent, lease, sell, deal in, convey or otherwise dispose of lands, tenements, hereditaments and appurtenances.
 - 6. To acquire by purchase or otherwise, construct, own, use, operate, lease, sell, convey or otherwise dispose of telegraph and telephone lines, works, plants, systems and equipments, and all rights of way therefor, and all rights to collect tolls and rates for the use and service therefor, and all franchises and privileges therefor.
 - To engage in, do and carry on any and all kinds of business pertaining to the irrigation of lands and the utilization of water for irrigation, power and other useful purposes.
 - 8. To borrow money for the business of the company and to give security therefor, and for the purposes of raising money necessary for the transaction of the business of the company or the acquisition of property, to execute bonds, debentures, promissory notes or other evidence of indebtedness, and to secure the same by mortgage or pledge or real estate or personal property.
 - To carry on any other business or to do any other thing in connection with said objects and purposes above mentioned that my [sic] be necessary or proper to successfully accomplish or promote said objects and purposes.

Articles of Incorporation, at Article II (Doc. 8.00). The record shows DCWC was created for the purpose of selling and distributing water, and that the current extent of the DCWC system was contemplated by the original appropriators and diligently pursued by the board and stockholders of the DCWC.

8. Irrigation claims 41U 127880-00 and 41U 127881-00 were decreed with the place of use listed as:

Based on the record, and as provided by the Settlement, the place of use legal land description for claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 should be modified to reflect a service area as described in Exhibit 1 of the Settlement. Additionally, the following information remark should be added to claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00:

A TOTAL OF UP TO 7501.00 ACRES WITHIN THE DESCRIBED HISTORICAL SERVICE AREA MAY BE IRRIGATED DURING ANY GIVEN IRRIGATION SEASON. A MAP OF THE SERVICE AREA IS FOUND IN THE CASE FILE FOR WATER COURT CASE 41U-0124-R-2023.

PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court is required to address all issue remarks decreed on a claim as well as objections filed. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. Service areas are recognized under Montana law as the proper method of describing a place of use for entities such as DCWC. While "[t]he Water Use Act does not specifically mention the concept of a service area to define a place of use" the Water Court "may recognize a service area place of use if a service area is part of 'the use of

water that would be protected under the law as it existed prior to July 1, 1973." Case 41H-0250-R-2020, *2 (citing Mont. Const. Art. IX, § 3(1) and quoting Mont. Code Ann. § 85-2-102(13)). The Water Court recognizes service areas "where an appropriator distributes water to other water users within some defined area under some kind of contractual, corporate, transactional, or statutory structure." Id., *3. DCWC fits the description.

4. Service areas are the proper method for defining the place of use for entities that hold water out for sale to others, the relationship of which is defined in their organizational documents. *East Bench Irr. Dist. v. Open A Ranch, Inc.*, 2021 MT 319, ¶ 76, 406 Mont. 502, 501 P.3d 380. In *Curry v. Pondera County Canal & Reservoir Co.*, the Court explained that unlike private irrigation rights, water rights developed by public service corporations are not appurtenant to historic places of use because the public service corporation retains ownership of the water right itself while the landowning shareholders become "the conduit for beneficial use" when they select portions of their land to irrigate. 2016 MT 77, ¶¶ 43-44, 383 Mont. 93, 370 P.3d 440.

Based on the Settlement and the record in this Case, claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 should be modified to reflect a service area.

5. The notice-type issue remarks decreed on claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 have served their purpose. As the Objections in this Case have been resolved, no further proceedings are required.

RECOMMENDATIONS

- 1. The ownership of claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 should be changed to Dearborn Canal and Water Co.
- 2. The places of use for claims 41U 127880-00, 41U 127881-00, 41U 127882-00, and 41U 127883-00 should be modified to describe a service area as shown on the attached Post Decree Abstracts. Additionally, an information remark should be added to the claims stating:

A TOTAL OF UP TO 7501.00 ACRES WITHIN THE DESCRIBED HISTORICAL SERVICE AREA MAY BE IRRIGATED DURING ANY GIVEN IRRIGATION SEASON. A MAP OF THE SERVICE AREA IS FOUND IN THE CASE FILE FOR WATER COURT CASE 41U-0124-R-2023.
