MASTER'S REPORT

FINDINGS OF FACT

1. Exempt stock claim 42M 30142597 was decreed with a notice-type issue

remark:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 42M DECREE ISSUED 01/24/2014.

2. The United States of America (Bureau of Land Management) objected to

claim 42M 30142597, stating:

9. State the changes you think should be made to this claim and why. State the specific grounds and evidence on which the Objection is based.

42M 30142597 is a Bureau of Land Management (BLM) water right claim that was split to create 42M 30152743 in 2021 when certain lands in the place of use were transferred to the State of Montana. 42M 30142597 retains the points of diversion and places of use on federal land, while 42M 30152743 contains the points of diversion and places of use on what is now state land. The abstracts generated after the split erroneously list the Montana State Board of Land Commissioners as the owner of 42M 30142597. Ownership should be corrected to the United States of America (Bureau of Land Management).

3. As the DNRC handles ownership changes and can correct ownership errors it may have made in splitting claim 42M 30142597, it was unclear how the Bureau of Land Management intended to resolve its Objection at the Water Court. An Order was issued on September 18, 2023 setting a deadline for the Bureau of Land Management to file a statement indicating how the Objection to claim 42M 30142597 should be resolved.

4. On September 28, 2023, the Bureau of Land Management confirmed ownership of claim 42M 30142597 has been updated and the Objection to claim 42M 30142597 "may be deemed resolved or withdrawn."

PRINCIPLES AND CONCLUSIONS OF LAW

1. The Water Court must address all issue remarks decreed on a claim as well as any objections filed. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.

2. The issue remark stating claim 42M 30142597 was not included in the 2014 Decree has served its notice purpose. As the Objection to claim 42M 30142597 has been resolved, the issue remark can be removed from the claim.

RECOMMENDATION

1. The issue remark should be removed from 42M 30142597.

A Post Decree Abstract of Water Right Claim is served with the Report for review.
