ORDER AMENDING AND ADOPTING MASTER’S REPORT

Pursuant to Montana Code Annotated, § 85-2-233(5), the above entitled case was assigned to Water Master Julia Nordlund. The Water Master filed a report containing Findings of Fact and Conclusions of Law with the Clerk of Court. Copies of the report were served upon the parties on September 13, 2023. Objections to the Master’s Report were filed by Dry Creek Canal Company on September 22, 2023. Objections to the Master’s Report were also filed by James and Janet McGehee, however, McGehees are not parties to this case. The comments pointed out the following typographical errors or Master’s misinterpretations from the Motion to Amend:

Finding of Fact No. 7: contains a clerical error regarding the maximum number of acres irrigated. This should be corrected to **5,110**.

Finding of Fact No. 15: inappropriately included claim 43BJ 114699-00 when it stated all these claims should have a period of use and diversion of May 1- October 15.

Period of use and diversion should be corrected on the post decree abstract for claim 43BJ 114699-00 back to **May 1- November 1**.

Post Decree Abstracts claims 43BJ 114697-00, 43BJ 114698-00, and 43BJ 114699-00: each contain a clerical error in the township of POU ID 24 which should read **1N**.

Post Decree Abstracts claim 43BJ 114698-00: contains a clerical error in the township of POU ID 32 which should read **1N**.

The Court has reviewed the Water Master's Findings and Conclusions. Pursuant to Rule 53(e), Montana Rules of Civil Procedure, the Court **ADOPTS** the September 13, 2023 Master's Report with the corrections listed above, and

ORDERS that **Post Decree Abstract of Water Right Claims** be served with this Order to confirm that the recommendations set forth in the Master's Report, as amended by this Order, have been adopted.
