If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.


MASTER'S REPORT

FINDINGS OF FACT

- 1. J Bar L Ranches, LLC (J Bar L) is the record owner of claim 43BV 127326-00.
- 2. Claim 43BV 127326-00 was decreed with a DNRC issue remark indicating the flow rate is missing.
 - 3. J Bar L objected to claim 43BV 127326-00, stating:

The location of the spring should be corrected to more accurately reflect historical beneficial use. It appears the spring may be located in the SESENW of Section 31, T4N, R 16E and the means of diversion is a developed spring.

- 4. On September 21, 2023, J Bar L filed a Motion to Modify Preliminary Decree of Water Right 43BV 127326-00. (Doc. 12.00); the Declaration of ranch manager Andrew Anderson was attached (Exhibit 1), a map (Exhibit A), and a proposed abstract (Exhibit 2) were also attached.
- 5. According to the record, claim 43BV 127326-00 should be modified to reflect the historical use of the claim as follows:



- 1. The Water Court is required to address all issue remarks decreed on a claim as well as any objections filed. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

RECOMMENDATIONS

1. Claims 43BV 127326-00 should be modified as shown in Finding of Fact No. 5.
