MASTER'S REPORT

FINDINGS OF FACT

1. J Bar L Ranches, LLC (J Bar L) is the record owner of claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, 43BV 127352-00, 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00.

2. Issue remarks were decreed on claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, 43BV 127352-00, and 43BV 211802-00:

Claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00:

POINT OF DIVERSION NO. 1 APPEARS TO BE LOCATED IN THE NWSWSW SEC 27, T4N, R15E, SWEET GRASS COUNTY.

ALTHOUGH NOT OBJECTED TO, THE ACRES IRRIGATED HAS BEEN REDUCED TO REFLECT THE CHANGE IN PLACE OF USE. THIS MAY BE HEARD AT THE PRELIMINARY DECREE STAGE.

Claim 43BV 211802-00:

THE CLAIMED FLOW RATE EXCEEDS THE 17 GPM PER ACRE GUIDELINE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA. THE FLOW RATE EQUALS 20.00 GPM PER ACRE.

3. J Bar L objected to claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00.

4. A deadline was set to determine if J Bar L agreed point of diversion No. 1 on claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 should be modified, resolving the point of diversion issue remark, as follows:

The Order Setting Filing Deadline also set a deadline for J Bar L to address its Objections. (Doc.¹ 1.00).

¹ "Doc." numerical references correlate to case file docket numbers in the Water Court's Full Court case management system.

5. On October 17, 2023, J Bar L filed its Statement and Response to Order Consolidating Case and Order Setting Filing Deadline and Request for Relief. (Doc. 4.00).

6. In its October 17, 2023 Response, J Bar L confirmed it agrees the point of diversion for claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 should be modified as shown in Finding of Fact No. 4.²

7. During adjudication of the Temporary Preliminary Decree in Basin 43BV, a Master's Report was issued in Case 43BV-26, implying claims 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00 from parent claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00, based on *Mont. Dep't of State Lands v. Pettibone*, 216 Mont. 361, 702 P.2d 948 (1985). On June 22, 1988, when the Master's Report was issued in Case 43BV-26, the record owner of claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 was Norman K. Starr and Divide Ranch Inc. and the record owner of claims 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00 was the Montana State Board of Land Commissioners.

8. J Bar L is the present record owner of claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, 43BV 127352-00, 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00. The October 17, 2023 Response requests parent claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 be re-combined with child claims 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00, restoring the originally claimed place of use, flow rate, and point of diversion. Furthermore, J Bar L requests child claims 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00 be dismissed.

9. In addition to point of diversion No. 1 (Lowery Ditch) being modified as described in Finding of Fact No. 4, for claims 43BV 127347-00, 43BV 127350-00, 43BV

127351-00, and 43BV 127352-00, another point of diversion should be added to the claims in the NWSESW of Section 36, Township 4 North, Range 15 East, Sweet Grass County, for Crum Ditch. Additionally, the places of use for claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 should be increased from 367.00 acres to 371.00 acres, reflecting an additional 4.00 acre place of use in the E2SWSE of Section 36, Township 4 North, Range 15 East, Sweet Grass County. Finally, the flow rates for claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 should be increased, as follows:

PRINCIPLES AND CONCLUSIONS OF LAW

1. The Water Court is required to address all issue remarks decreed on claims as well as any objections filed. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.

2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

3. Claims 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00 were created as implied claims when the parent claims were split. *See* Master's Report, Case 43BV-26 (June 22, 1988), adopted Aug. 3, 1988 (copy in claim files). Now, there is unity of title and J Bar L seeks to re-combine the claims, requiring modifications to the parent claims and dismissal of the implied claims. J Bar L's proposal will not negatively affect other water users because the modifications do not add more

irrigated acres, more flow rate, or an additional point of diversion – they are merely re-combined as originally claimed.

RECOMMENDATIONS

1. In addition to point of diversion No. 1 (Lowery Ditch) being modified as described in Finding of Fact No. 4, another point of diversion should be added to claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00, in the NWSESW of Section 36, Township 4 North, Range 15 East, Sweet Grass County, for Crum Ditch. Additionally, the places of use for claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 should be increased from 367.00 acres to 371.00 acres with an additional 4.00 acre place of use in the E2SWSE of Section 36, Township 4 North, Range 15 East, Sweet Grass County. Finally, the flow rates for claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00 should be increased, as follows:

2. Claims 43BV 211802-00, 43BV 211803-00, 43BV 211804-00, and 43BV 211805-00 should be dismissed.

3. The issue remarks should be removed from claims for claims 43BV 127347-00, 43BV 127350-00, 43BV 127351-00, and 43BV 127352-00,
