## **MASTER'S REPORT**

All water right claims that appeared in the Interlocutory Decree for Pryor Creek (Basin 43E) were subject to "issue remarks" resulting from pre-decree examination by

the DNRC, objections, and counterobjections. Each of the above-captioned claims received objections from the United States Department of Interior Bureau of Indian Affairs ("BIA"), self-objections, and issue remarks during the DNRC's claims reexamination.

The claims were consolidated into Case 43E-0120-I-2023 to resolve the objections, self-objections, and issue remarks.

# **FINDINGS OF FACT**

- 1. Sunlight Ranch Co. ("Sunlight") is the record owner of claims 43E 30145156, 43E 30145159, 43E 30145171, and 43E 30145172.
- 2. Claims 43E 30145156, 43E 30145159, 43E 30145171, and 43E 30145172 were decreed with DNRC issue remarks:

#### 43E 30145171:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43E DECREE ISSUED 02/25/2010.

THE TYPE OF HISTORICAL RIGHT AND PRIORITY DATE MAY BE QUESTIONABLE. DOCUMENTATION TO SUPPORT THE TYPE OF HISTORICAL RIGHT AND PRIORITY DATE WAS NOT SUBMITTED WITH THIS CLAIM. THIS CLAIM DOES NOT APPEAR TO REFLECT THE WATER RIGHT AS IT WAS BEFORE JULY 1, 1973.

#### 43E 30145156, 43E 30145159, and 43E 30145172:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43E DECREE ISSUED 02/25/2010.

THE TYPE OF HISTORICAL RIGHT AND PRIORITY DATE MAY BE QUESTIONABLE. DOCUMENTATION TO SUPPORT THE TYPE OF HISTORICAL RIGHT AND PRIORITY DATE WAS NOT SUBMITTED WITH THIS CLAIM.

- 3. BIA and Sunlight objected to claims 43E 30145156, 43E 30145159, 43E 30145171, and 43E 30145172. A deadline was set for the parties to file settlement documents addressing the Objections and issue remarks.
- 4. On May 19, 2023, Sunlight filed a *Motion to Amend Water Right Claim No.* 30145163, originally consolidated in Water Court case 43E-0120-I-2023, to re-basin the claim in Basin 43P. Claim 43E 30145163 was reconsolidated into Water Court case 43E-0130-I-2023 and assigned to Associate Water Judge Stephen Brown to address the *Motion*.
- 5. On May 30, 2023, the BIA and Sunlight filed a *Stipulation* regarding the resolution of the objections and issue remarks appearing on claims 43E 30145156, 43E 30145159, 43E 30145171, and 43E 30145172 along with a proposed abstract for claim

43E 30145156 and maps. The *Stipulation* requests the following changes be made to the claims in this Case, resolving the Objections and addressing the issue remarks decreed on the claims. In the interest of clarity, the entire place of use for claim 43E 30145156, as described in the proposed abstract attached to the *Stipulation*, is displayed below along with the requested information remarks to signify each of the changes proposed to the elements for claim 41K 30145156 and the remaining claims in the case. The requested modifications are as follows:

# PRINCIPLES OF LAW

- 1. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
- 2. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.
- 3. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

4. The Water Court is not bound by parties' settlement agreements. Any settlement reached by the parties is subject to review and approval by the Water Court. Rule 17(a), W.R.Adj.R.

# CONCLUSIONS OF LAW

- 1. Based on the information received in the *Stipulation*, claims 43E 30145156, 43E 30145159, 43E 30145171, and 43E 30145172 should be modified as described in Finding of Fact No. 5. The modifications resolve the objections, self-objections, and substantive issue remarks appearing on the claims.
- 2. The notice-type issue remarks appearing on each claim served their notice purpose and should be removed from the claims.

# RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court adopt the changes as outlined above.

Post decree abstracts of each water right claim reflecting the recommended changes are attached to this Report.
