NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

On April 1, 2024, the Estate of Gary Dahl submitted a Motion to Amend claim 40S 46431-00. The Motion is based on a typographical error on the place of use. Since the Estate of Gary Dahl ended its ownership of the claim at the end of 2023, the Court set

a filing deadline for new claimants Lorrain Nichols, Arlyn Pankratz, and Roger Pankratz to state if they agreed with the Motion. On July 22, 2024, each of the claimants filed their consent to the Motion to Amend.

FINDINGS OF FACT

- 1. The original Statement of Claim for 40S 46431-00 claimed several direct from source places of use and points of diversion. Point of diversion ID 21 and Place of Use ID 1 are claimed in the SWSW Sec. 1, Twp. 30N, Rge. 44E.
- 2. At some point during the DNRC's examination of this claim, the description for both the place of use and point of diversion was refined to the W2SWSW Sec. 1. However, when DNRC made that refinement, it inadvertently changed the place of use range to 45E.
- 3. The Amendment from Claimants states the place of use should be SWSW Sec. 1, Twp. 30N, Rge. **44E**.
- 4. The map attached to the Motion shows the request accurately reflects historical usage. Given that this is a direct from source stock claim, it would be impossible for the place of use to not sync with the points of diversion.
- 5. The error regarding the legal descriptions of the place of use went unnoticed during the Temporary Preliminary Decree.

CONCLUSIONS OF LAW

- 1. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that an element of the prima facie claim is incorrect. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R. A preponderance of the evidence is evidence that demonstrates the fact to be proved is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶33, 357 Mont. 348, 240 P.3d 628.
- 2. The Montana Water Court is permitted to use information submitted by the Department of Natural Resources and Conservation, the statement of claim, information

from approved compacts, and any other data obtained by the Court to evaluate water right claims. Section 85-2-231(2), MCA.

3. Pursuant to § 85-2-227(2), MCA:

A water judge may consider all relevant evidence in the determination and interpretation of existing water rights. Relevant evidence under this part may include admissible evidence arising before or after July 1, 1973.

- 4. The evidence entered into the record is sufficient to support making the correction above.
- 5. The change to the place of use would neither result in an expansion of the water right nor negatively impact anyone other than Claimant and thus results in no need for notice pursuant to Section 85-2-233(6), MCA.

RECOMMENDATIONS

Based upon the above Findings of Fact and Conclusions of Law, this Master recommends that the Court make the changes specified above to correct the Preliminary Decree for this Basin. A Post Decree Abstract of Water Right Claim is served with this Report to confirm that the recommended changes have been made in the state's centralized record system.
