### **NOTICE OF FILING OF MASTER'S REPORT**

This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days to be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

### **MASTER'S REPORT**

The water right claims listed above appeared in the Preliminary Decree for the Boulder River, Tributary of Jefferson River (Basin 41E) issued on October 19, 2022. Each claim received issue remarks from the Department of Natural Resources and

Conservation (“DNRC”) raising potential legal or factual issues with the claim. The Water Court consolidated the claims into case 41E-0234-R-2024 to address these issues.

The Court ordered the Claimants to work with the DNRC to resolve the issue remarks on the claims. The Claimants met with DNRC and DNRC Water Resource Specialist Jason Larsen filed a Memorandum with the Court on April 25, 2024 (“DNRC Memo”). Doc. 3.00.<sup>1</sup> The DNRC Memo made recommendations as to how to resolve the issue remarks based on DNRC’s discussion with the Claimants and review of the claim abstracts, claim files, aerial photos, and a site visit to get GPS coordinates.

Claimant NR & EJ Limited Partnership filed its Endorsement of DNRC Memo, agreeing with the DNRC’s recommendations on May 14, 2024. Doc. 4.00. The Court ordered the remaining claimants to review the DNRC Memo and inform the Court if they disagreed with the recommendations. The Court informed the Claimants that if nothing were filed, the Court would conclude the Claimants agree with the DNRC recommendations. Nothing was filed by the deadline.

#### FINDINGS OF FACT

1. Water right claims 41E 94025-00 and 41E 94026-00 appeared in the Preliminary Decree with the following substantive issue remark:

THE POINT OF DIVERSION NO. 1 APPEARS TO BE INCORRECT. THE POINT OF DIVERSION NO. 1 APPEARS TO BE NWNESE SEC 15 TWP 6N RGE 4W JEFFERSON COUNTY.

Each claim’s point of diversion No. 1 should be corrected as follows as recommended by the DNRC Memo:

41E 94026-00:

DITCH NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

#### PRINCIPLES OF LAW

1. Section 85-2-248(2), MCA requires the Water Court to resolve all issue remarks that are not resolved through the objection process. The Montana Water Court has the authority to resolve issue remarks when the claim file and information available to the Court provide a sufficient basis to do so. § 85-2-248(3), MCA.

2. A properly filed claim of an existing right or an amended claim of existing right is *prima facie* proof of its content. § 85-2-227, MCA. This *prima facie* proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.ADJ.R.

#### CONCLUSIONS OF LAW

1. The Findings of Fact above are supported by a preponderance of the evidence. The claims should be modified as described above. The substantive issue remarks are resolved by the modifications described above. The Notice Only Remarks have served their notice purpose. The issue remarks should be removed from the claims.

#### RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court make the changes specified in the Findings of Fact above and remove the issue remarks from the claims.

A Post Decree Abstract of Water Right Claim for each claim reflecting the recommended changes is attached to this Report for review.
