If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

#### **MASTER'S REPORT**

Water right claim 41I 6753-00 appeared in the Preliminary Decree for the Missouri River above Holter Dam (Basin 41I) issued on June 24, 2022. The claim did not receive objections but received an issue remark from the Department of Natural Resources and Conservation (DNRC) raising potential legal or factual issues with the claim. Claim 41I 6753-00 is consolidated into Water Court Case 41I-2053-R-2024 to address the remark.

# FINDINGS OF FACT

1. Claim 41I 6753-00 is an irrigation claim to 4.00 CFS of Crow Creek water based on a decreed right in Case 236, Broadwater County. It appeared in the Preliminary Decree with the following issue remark.

THE CLAIMED FLOW RATE EXCEEDS THE 17 GPM PER ACRE GUIDELINE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA. THE FLOW RATE EQUALS 22.00 GPM PER ACRE

This issue remark is based solely on DNRC guidelines, not facts specific to the claimed water right.

# PRINCIPLES OF LAW

- 1. Section 85-2-248(2), MCA requires the Water Court to resolve all issue remarks that are not resolved through the objection process. The Montana Water Court has the authority to resolve issue remarks when the claim file and information available to the Court provide a sufficient basis to do so. § 85-2-248(3), MCA.
- 2. A properly filed claim of an existing right or an amended claim of existing right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.

# CONCLUSIONS OF LAW

1. The Findings of Fact above are supported by a preponderance of the evidence. The issue remark fails to overcome the prima facie status of the Statement of Claim, and should be removed from the claim.

# **RECOMMENDATIONS**

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court remove the issue remark from the claim.

A Post Decree Abstract of Water Right Claim for the claim reflecting the recommended changes is attached to this Report for review.
