MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Judith River (Basin 41S) with issue remarks.

The claims were consolidated into Case 41S-0210-R-2024 on February 26, 2024, and the claimants were ordered to work with the Department of Natural Resources and Conservation to resolve the issue remarks on the claims. On June 12, 2024, a Memorandum ("Memo") was filed (Doc. 1 2.00). Maps showing the points of diversion and places of use for the claims were attached to the Memo (Doc. 3.00-4.00). The Memo states that DNRC met with claimant Norman Ranch and that the claimant had no objections to the DNRC findings.

FINDINGS OF FACT

1. Claim 41S 33614-00 was decreed with the following issue remarks: THE MEANS OF DIVERSION APPEARS TO BE INCORRECT. THE MEANS OF DIVERSION APPEARS TO BE A DAM.

THE MEANS OF DIVERSION APPEARS TO BE INCORRECT. A RESERVOIR IS CLAIMED. THEREFORE, IT APPEARS THE MEANS OF DIVERSION SHOULD BE "DAM."

THE CLAIMANT DID NOT IDENTIFY THE PERIOD OF DIVERSION FOR THIS RIGHT. A PERIOD OF DIVERSION HAS BEEN ADDED TO MATCH THE PERIOD OF USE. IF NO OBJECTIONS ARE RECEIVED TO THE PERIOD OF DIVERSION OR PERIOD OF USE, THOSE ELEMENTS WILL BE DECREED AS SHOWN ON THIS ABSTRACT AND THIS ISSUE REMARK WILL BE REMOVED FROM THIS CLAIM.

THE FERGUS COUNTY WATER RESOURCES SURVEY (1970) APPEARS TO INDICATE 47.50 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

THE CLAIMED VOLUME APPEARS TO BE EXCESSIVE FOR THE CLAIMED PURPOSE. THE CLAIMED VOLUME EQUALS 3.81 TIMES THE CAPACITY OF THE RESERVOIR.

2. The Memo recommends reducing the maximum acreage to 47.50 acres, the volume to 148.96 AC-ft and the means of diversion to 'dam'. The Memo stated that modifying the claim thusly would resolve the 'acres irrigated' issue remarks, the volume

THE FERGUS COUNTY WATER RESOURCES SURVEY (1970) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.

USDA AERIAL PHOTOGRAPH NO(S). 30027-278 26, DATED 09/25/1979, APPEARS TO INDICATE 0.00 ACRES IRRIGATED.

THE CLAIMED POINT OF DIVERSION IS IN QUESTION. THE LOCATION OF THE DIKE CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

BASED ON THE 12/31/1998 DNRC REPORT TO THE WATER COURT, IT APPEARS A SUPPLEMENTAL RIGHTS REMARK SHOULD BE ADDED FOR THIS CLAIM AND CLAIM 41S 211097-00.

- 12. The Memo recommends reducing the maximum acres to 71 acres and reducing the flow rate to 2.69 CFS. The Memo states that adoption of the recommendations would resolve the 'acres irrigated' and flow rate issue remarks. The Memo further recommends removal of the point of diversion issue remark.
 - 13. Claim 41S 34698-00 was decreed with the following issue remarks:

The Memo states that adoption of the recommendations would resolve the 'acres irrigated', volume and flow rate issue remarks. The Memo further recommends removal of the 'supplemental acres' issue remark.
 - 15. Claim 41S 34699-00 was decreed with the following issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

THE CLAIMED FLOW RATE EXCEEDS THE 17 GPM PER ACRE GUIDELINE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA. THE FLOW RATE EQUALS 25.00 GPM PER ACRE.

The Memo states that adoption of the recommendations would resolve the 'acres irrigated', volume and flow rate issue remarks. The Memo further recommends removal of the 'supplemental acres' issue remark.

17. Claim 41S 37835-00 was decreed with the following issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

WHEN THIS CLAIM WAS ORIGINALLY DECREED, THE PERIOD OF DIVERSION WAS NOT INCLUDED AS AN ELEMENT OF THE CLAIM. IN 2008, THE PERIOD OF DIVERSION ELEMENT WAS ADDED TO ALL CLAIM ABSTRACTS. EXISTENCE OF THE CLAIMED RESERVOIR CANNOT BE CONFIRMED WITH AVAILABLE DATA.

THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

- 18. The Memo recommends modifying the period of use to year-round in order to resolve the period of diversion issue remark. Period of use is not implicated by the current issue remarks. This Master is interpreting the recommendation to modify period of use to year-round as a recommendation to modify period of diversion to year-round, as is common for claims utilizing an onstream reservoir as claim 41S 37835-00 does.
- 19. The Memo recommends the removal of the remaining issue remarks without modifications to the claim.

IF NO OBJECTIONS ARE RECEIVED TO THE PERIOD OF DIVERSION OR PERIOD OF USE, THOSE ELEMENTS WILL BE DECREED AS SHOWN ON THIS ABSTRACT AND THIS ISSUE REMARK WILL BE REMOVED FROM THIS CLAIM.

- 23. The Memo recommends modifying the means of diversion for point of diversion #1 to 'dam' in order to resolve the means of diversion issue remark. The Memo further recommended modifying the period of use to year-round. The Recommendation to modify the period of use was unsupported and otherwise without explanation of why the irrigation claim should be decreed with a year-round period of use.

THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

THE CLAIMED VOLUME EXCEEDS THE MAXIMUM FEASIBLE VOLUME. BASED ON THE FLOW RATE AND PERIOD OF USE. THE MAXIMUM VOLUME POSSIBLE IS 59.39 ACRE-FEET PER YEAR.

- 25. The Memo recommends reducing the maximum acres to 47.50 acres and reducing the volume to 30.40 AC-ft. The Memo states that adoption of the recommendations would resolve the 'acres irrigated' and volume issue remarks. The Memo further recommends removal of the 'supplemental acres' and flow rate issue remarks.

The Memo further states that the point of diversion was located where it was originally claimed.
 - 28. Claim 41S 211097-00 was decreed with the following issue remarks:

- 29. The Memo recommended removal of the issue remarks without modifications to the claim.

THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

31. The Memo recommends reducing the maximum acres to 50 acres. The Memo states that adoption of the recommendation would resolve the 'acres irrigated' and 'supplemental acres' issue remarks. The Memo further states that the point of diversion was located where it was originally claimed.

PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.
- 3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.

CONCLUSIONS OF LAW

- 1. The DNRC recommendations for all claims except for claims 41S 37835-00 and 41S 37837-00 should be adopted.
 - 2. The recommendations regarding period of use for claims 41S 37835-00 and 41S

37837-00 are unsupported and should not be adopted.
