#### **MASTER'S REPORT**

### FINDINGS OF FACT

- 1. Four J Ranch Inc. is the record owner of stock claim 42M 164424-00.
- 2. Claim 42M 164424-00 was decreed with the following DNRC issue remark:

THIS CLAIM AND WATER RIGHT NO. 42M-46348 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

The Water Court is required to resolve the issues raised by issue remarks.

- 3. Based on information in the record, it appeared claim 42M 164424-00 is duplicated by groundwater certificate 42M 46348-00 and claim 42M 164424-00 should be dismissed.
- 4. An Order was issued setting a deadline for Claimant Four J Ranch Inc. to agree or disagree that claim 42M 164424-00 should be dismissed. The Order indicated that if nothing were filed by the deadline, this Water Master would conclude that Four J Ranch Inc. agrees claim 42M 164424-00 should be dismissed. The Order included the following language:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed by the deadline.

# PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The issue remarks were not addressed through the objection process. The Water Court is required to resolve the issues raised by each issue remark. Section 85-2-248, MCA. Under Section 85-2-248(3), MCA, information in the claim file or other information obtained by the Court can be reviewed to determine if it provides a sufficient basis to resolve the issue raised by a remark and the Court can provide the claimant an opportunity to file additional information or evidence.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. Pursuant to Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.

# **RECOMMENDATION**

1. Claim 42M 164424-00 should be dismissed. An abstract is attached to this Report for review.
