### **MASTER'S REPORT**

The above-captioned claim appeared in the Preliminary Decree for the Judith River (Basin 41S) and received an objection from the United States (Bureau of Land Management) ("BLM"). The claim was consolidated into Case 41S-0016-R-2024 on February 15, 2024, and on August 2, 2024 a Stipulation signed by the BLM and Claimant Majorie Boyce was filed resolving the objection (Doc. 18.00).

## FINDING OF FACT

1. Pursuant to the Stipulation, the following remark should be placed on claim 41S 122892-00 should be modified as follows:

#### THE POINTS OF DIVERSION AND PLACE OF USE ARE LIMITED TO PRIVATE LAND.

### PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.
- 3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.
- 4. "The Water Court is not bound by settlement agreements. Any settlement reached by the parties is subject to review and approval by the Water Court." Rule 17(a), W.R.Adj.R; *In re Argabright*, 2014 Mont. Water LEXIS 9, 41I 265 (December 12, 2014).
