MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Judith River (Basin 41S) with the following substantive issue remarks:

41S 115271-00:

The claims were consolidated into Case 41S-0151-R-2024 on February 12, 2024 and on July 19, 2024, claimant McMillan Trust filed a Status Report detailing their proposed resolution to the issue remarks as well as a proposed abstract and map for claim 41S 115274-00 (Doc. 1 3.00).

FINDINGS OF FACT

- 1. Pursuant to the Status Report, claims 41S 115271-00 and 41S 139536-00 should be dismissed.
- 2. Pursuant to the Status Report, claim 41S 115274-00 should be modified as follows:

3. The remaining issue remarks are 'notice' type remarks that do not require further proceedings or information to resolve. The remarks have served their purpose and should be removed from the claims.

PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.
- 3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. §§ 85-2-227, -231(2), MCA.

CONCLUSION OF LAW

1. The modification to the point of diversion and place of use for claim 41S 115274-00 resolves the issue remark on the claim and is supported by the Status Report and associated documents.

RECOMMENDATION

- 1. Upon review the record in this case, claim 41S 115274-00 should be modified as discussed above. The issue remark should be removed from the claim.
 - 2. Claims 41S 115271-00 and 41S 139536-00 should be dismissed.
- 3. The remaining issue remarks should be removed from the claims as discussed above.
