- 8. **41S 139680-00** (Theodore D. Irish and Five Hundred Acre Wood, LLC): Mr. Ahlgren was unable to locate historic irrigation at the claimed place of use and Mr. Ahlgren recommended dismissal of the claim.

It appears Lewanna Joest is affiliated with Five Hundred Acre Wood LLC, which has been on the service list since the consolidation of this Case. Further, as both a Claimant and a member of the public, no Order is required for Five Hundred Acre Wood LLC to meet with the DNRC in its official capacity. It appeared Ms. Joest was requesting additional time to clarify the issues involved in Case 41S-0834-R-2024 and meet with DNRC, if appropriate. An Order was issued extending the deadline to agree or disagree with the proposed modifications until November 25, 2024. Nothing was filed.

# PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court must address all issue remarks decreed on a claim. Section 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

- 3. The source name information remarks decreed on claims 41S 28846-00, 41S 30996-00, 41S 30997-00, 41S 30998-00, 41S 139680-00, and 41S 139681-00 indicated that if no objections were filed, the remarks would be removed with no changes to the claim; no objections were filed, and the remarks can be removed
- 4. The issue remarks decreed on claims 41S 28846-00, 41S 30996-00, 41S 30998-00, and 41S 139680-00 indicating the "maximum combined acres for this group of supplemental claims may require modification..." is not relevant because supplemental rights remarks on claims no longer include a quantified acreage figure.


