## **CLOSING ORDER**

The Water Court included water right claims 43BV 30137206, 43BV 30137256, 43BV 30137301, 43BV 30137302, 43BV 30137303, 43BV 30137304, 43BV 30137305, 43BV 30137306, 43BV 30137745, 43BV 30137746, 43BV 30137752, and 43BV 30137754 in the Preliminary Decree for the Sweet Grass Creek Basin (Basin 43BV). The claims describe rights to use water from various springs that are tributary to Sweet Grass Creek for stock water use with a December 31, 1878 priority date.

Cargill Land Company ("Cargill") owns each of the claims. Greg H. Langford and Vickie L. Langford ("Langfords") filed objections based primarily on the claimed priority dates. Additionally, the claims also all include the following issue remark:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 43BV DECREE ISSUED 12/19/1984.

The Court consolidated the claims into this case to address the Langfords objections. After various proceedings, the parties filed an executed stipulation (the "Stipulation"). Under the terms of the Stipulation, Cargill agreed to accept more junior priority dates on each of the claims based on dates of federal land patents. The Langfords agreed to withdraw their objections based on the more junior priority dates. The priority date modifications for each claim are as follows:

The Water Court may accept a claimant's requested reduction or limitation without further presentation of evidence unless there is an unresolved issue remark on the claim. Rule 17(c), W.R.Adj.R. As this is a reduction in priority, the Stipulation is approved. Moreover, even though the parties did not attach the actual supporting patent documents, their representation that the modified priority dates is based on homestead patenting is consistent with evidence used in Water Court proceedings. *See, e.g., In re Danreuther Ranches*, 2017 MT 241, ¶ 25, 389 Mont. 15, 403 P.3d 332; *Twin Creeks Farm & Ranch, LLC v. Petrolia Irrigation Dist.*, 2022 MT 19, ¶ 24, 407 Mont. 278, 502 P.3d 1080.

The issue remark also is resolved for each claim. The issue remark gave notice that the claims did not appear in the temporary preliminary decree ("TPD") for Basin 43BV, which the Water Court issued in 1985, because the TPD predated the exempt claim filing deadline. Other than the Langfords, the claims did not receive any objections.

Absent any other objections, the remarks on the claims do not raise any factual or legal issues that need to be addressed. No further proceedings are required to resolve the remark and the remark is removed from the abstract of each claim in this case.

### **ORDER**

Therefore it is ORDERED that the Stipulation is accepted, the claims are modified as provided in this Order with all issue remarks and objections resolved.

Post decree abstracts of the claims are included with this Order to confirm the modifications have been made in the State's centralized water rights record system.
