MASTER'S REPORT

FINDINGS OF FACT

- 1. River Bottom Ranch, LLC (River Bottom) is the record owner of stock claim 39F 30139133. The United States of America (BLM) is the record owner of claim 39F 30140242.
- 2. Claims 39F 30139133 and 39F 30140242 were decreed with DNRC issue remarks:

39F 30139133:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 39F DECREE ISSUED 05/23/2019.

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT WERE FILED BY DIFFERENT PARTIES WHO CLAIM OVERLAPPING PLACES OF USE. 30139133, 30140242.

THE OWNERSHIP OF THIS RIGHT MAY BE QUESTIONABLE. PART OR ALL OF THE PLACE OF USE APPEARS TO BE ON FEDERAL LAND. (BLM)

3. River Bottom objected to claim 39F 30139133; the Objection indicated additional points of diversion and places of use should be added:

This claim includes additional points of diversion and places of use in: N2NWNE-25-5S-59E; S2SWSE-24-5S-59E Evidence supporting the historical use of the claim, as identified in the Objection, was not included with the Objection, nor was a map, or proposed abstract.

- 4. A deadline was set for the parties to address the issue remarks and the Objection.
- 5. On June 28, 2024, River Bottom filed its Response to Order Setting Filing Deadline. (Doc. 12.00). The Response explained that when filing claim 39F 30139133, errors were made for the point of diversion and place of use legal land descriptions placing a portion of the claim on federal land, resulting in the ownership issue remark and the overlapping place of use issue remark.

6. On July 19, 2024, the BLM filed its Response to Court Order, stating:

The United States believes that the modifications proposed by River Bottom Ranch LLC resolve any issues related to the United States' interests in this case. If other changes are proposed by the Court or the parties prior to the issuance of a final order in this case, the United States reserves its right to participate further in these proceedings.

(Doc. 3.00).

PRINCIPLES AND CONCLUSIONS OF LAW

1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

- 2. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.
- 3. The issue remarks noting that claims 39F 30139133 and 39F 30140242 were not included in the 2019 decree have served their purpose. As the Objection has been resolved, no further proceedings are required.

RECOMMENDATIONS

- Claim 39F 30139133 should be modified as shown in Finding of Fact No.
- 2. The issue remarks should be removed from claims 39F 30139133 and 39F 30140242.

Post Decree Abstracts of Water Right Claims are served with the Report for review.
