MASTER'S REPORT

FINDINGS OF FACT

1. The United States of America (Bureau of Land Management) is the record owner of livestock direct from source claim 39F 30140303.

2. Claim 39F 30140303 was decreed with DNRC issue remarks:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 39F DECREE ISSUED 05/23/2019.

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT WERE FILED BY DIFFERENT PARTIES WHO CLAIM OVERLAPPING PLACES OF USE. 174190-00, 30140303.

- 3. The first-listed remark is a notice-type remark and does not require further attention.
- 4. The second-listed remark indicates the place of use described on the abstract of claim 39F 30140303 may overlap with the place of use described on the abstract of direct from source stock claim 39F 174190-00. Claim 39F 174190-00 was decreed in the 2019 Preliminary Decree for Basin 39F; the Bureau of Land Management did not object to the place of use for the claim (nor did any other party).
- 5. A deadline was set for the Bureau of Land Management to address the overlapping place of use issue remark decreed on claim 39F 30140303. On July 10, the Bureau of Land Management filed its Response to Court Order. (Doc. 13.00). The Response references *BLM v. Barthelmess Ranch Corp.*, 2016 MT 348, 386 Mont. 121, 386 P.3d 952, where the Montana Supreme Court recognized private appropriators and the United States of America (Bureau of Land Management) can have an appropriation from the same source. When means of diversion are for livestock direct from source, overlapping places of use result because the place of use is the source. There is no issue to resolve.

PRINCIPLES AND CONCLUSIONS OF LAW

1. The issue remarks were not addressed through the objection process. The Water Court is required to resolve the issues raised by each issue remark. Section 85-2-248, MCA. Under Section 85-2-248(3), MCA, information in the claim file or other information obtained by the Court can be reviewed to determine if it provides a sufficient basis to resolve the issue raised by a remark and the Court can provide the Claimant an opportunity to file additional information or evidence.

- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. The notice-type issue remark decreed on claim 39F 30140303 has served its purpose. As no objections were filed, no further proceedings are required.

RECOMMENDATION

1. The issue remarks should be removed from claim 39F 30140303 with no changes to the elements of the claim.
