The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

**MASTER'S REPORT**

All water right claims that appeared in the Preliminary Decree for Sun River (Basin 41K) were subject to "issue remarks" resulting from pre-decree examination by the DNRC, objections, counterobjections, and notices of intent to appear ("NOIA").

Claims 41K 216284-00 and 41K 30007161 each received self-objections from Montana Trust Lands Management Division (“TLMD”). Claim 41K 216284-00 received an NOIA from Tee Bar Ranch Co. and claim 41K 30007161 received an NOIA from LF Ranch MT, LLC. The claims also received issue remarks during the DNRC’s review of the claims.

The above-captioned claims were consolidated into Case 41K-0092-R-2023 to resolve the objections and issue remarks.

### FINDINGS OF FACT

1. Claim 41K 46149-00 received the following issue remark:

THE CLAIMS LISTED FOLLOWING THIS STATEMENT MAY BE A MULTIPLE USE OF THE SAME RIGHT. THESE CLAIMS MAY NEED A MULTIPLE USE REMARK. 41K 216284-00, 41K 46149-00.

Claim 41K 216284-00 received the following issue remark:

THE CLAIMS LISTED FOLLOWING THIS STATEMENT MAY BE A MULTIPLE USE OF THE SAME RIGHT. THESE CLAIMS MAY NEED A MULTIPLE USE REMARK. 41K 216284-00, 41K 46149-00.

THE CLAIMED PRIORITY DATE MAY BE QUESTIONABLE. THE PRIORITY DATE ON THE SUBMITTED WATER COURT MASTER'S REPORT IS JUNE 1, 1888.

SOURCE NAME ON POD NO. 2 APPEARS TO BE INCORRECT. THE SOURCE NAME APPEARS TO BE AN UNNAMED TRIBUTARY OF ELK CREEK.

Claim 41K 46149-00 received the following issue remark:

THIS CLAIM AND WATER RIGHT NO. 41K 96522-00 APPEAR TO BE DUPLICATE FILINGS. IT APPEARS ONLY ONE WATER RIGHT IS INVOLVED.

THE POINT OF DIVERSION APPEARS TO BE INCORRECT. THE POINT OF DIVERSION APPEARS TO BE IN THE W2 SEC 36 TWP 20N RGE 7W LEWIS AND CLARK COUNTY.

THE CLAIMED SOURCE MAY BE QUESTIONABLE. BASED ON AVAILABLE DATA, THE SOURCE MAY BE SURFACE WATER FROM ELK CREEK.

2. A Status Conference for Case 41K-0092-R-2023 took place on November 29, 2023, by telephone conference call. Water Master Eugene C. White presided; claimant Barbara Krause was present along with her son Justin Krause; Terisa Oomans was present on behalf of claimant/objector State of Montana Board of Land Commissioners (“TLMD”); Ryan McLane was present on behalf of NOIA party Tee Bar

Ranch Co. (“Tee BAR”); and Ben Sudduth was present on behalf of NOIA party LF Ranch MT, LLC (“LF Ranch”).

During the conference, the parties discussed the multiple use issue remark appearing on claims 41K 46149-00 and 41K 216284-00, Ms. Oomans described the objections filed by TLMD, and Mr. McLane explained briefly the NOIA process.

3. On May 21, 2024, claimant/objector TLMD and claimants Barbara M. Krause Survivors Trust and John W. Krause Jr. Bypass Trust filed a *Stipulation* (Doc. 12.00)<sup>1</sup> The *Stipulation* proposes the following modification to resolve the objections and issue remarks for each of the above-captioned claims:

a. Revise the multiple use remark to 46149 to state:

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT  
ARE MULTIPLE USES OF THE SAME RIGHT. THE USE OF THIS  
RIGHT FOR SEVERAL PURPOSES DOES NOT INCREASE THE  
EXTENT OF THE WATER RIGHT. RATHER IT DECREASES THE  
RIGHT TO ALTERNATE AND EXCHANGE THE USE (PURPOSE)  
OF THE WATER IN ACCORD WITH HISTORICAL PRACTICES.

b. Revise the Priority Date on Claim 216284 to 6/1/1888;

c. Revise the Source for Place of Use No. 2 on 216284 to UT of Elk  
Creek;

- d. Add the following multiple use remark to 216284:

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT ARE MULTIPLE USES OF THE SAME RIGHT. THE USE OF THIS RIGHT FOR SEVERAL PURPOSES DOES NOT INCREASE THE EXTENT OF THE WATER RIGHT. RATHER IT DECREASES THE RIGHT TO ALTERNATE AND EXCHANGE THE USE (PURPOSE OF THE WATER IN ACCORD WITH HISTORICAL PRACTICES.

- e. Revise the Point of Diversion No. 1 on 30007161 to SWSWNW Sec 36, T20N R7W, Lewis and Clark County;
- f. Revise the Point of Diversion No. 2 on 30007161 to NWNWSW Sec 36, T20N R7W, Lewis and Clark County;
- g. Revise the Place of Use No. 1 on 30007161 to SWSWNW Sec 36, T20N R7W, Lewis and Clark County;
- h. Revise the Place of Use No. 2 on 30007161 to NWNWSW Sec 36, T20N R7W, Lewis and Clark County; and

4. On May 24, 2024, NOIA party Tee Bar filed a *Response to Stipulation* (Doc. 13.00)<sup>2</sup>. The *Response* states that if the stipulation is approved by the Court, and no other modifications are made to the claims, Tee Bar would deem its NOIAs resolved.

5. On May 28, 2024, NOIA party LF Ranch filed a *Conditional Withdrawal* of its NOIA (Doc. 14.00)<sup>3</sup>. The *Withdrawal* states that if the Court accepts and applies the corrections described in the stipulation, LF Ranch's NOIA would be resolved.

6. On July 10, 2024, claims 41K 46147-00 and 41K 46148-00 were called in on motion by the Water Court to allow for claim 41K 216284-00 to be added to the multiple use remark they share with claim 41K 46149-00.

### PRINCIPLES OF LAW

1. The Water Court is not bound by parties' settlement agreements. Any settlement reached by the parties is subject to review and approval by the Water Court. Rule 17(a), W.R.Adj.R.

2. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.

3. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

### CONCLUSIONS OF LAW

1. Based on the information contained in the *Stipulation*, the proposed modifications should be made to each of the claims as described in Finding of Fact No. 3. These modifications resolve the objections and issue remarks appearing on the above-captioned claims, and the issue remarks should be removed.

2. Based on the information contained in the *Response* filed by Tee Bar, and the *Conditional Withdrawal* filed by LF Ranch, the NOIAs should be considered resolved.

### RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Water Master recommends that the Court modify the claims as described in Finding of Fact No. 3 and remove the issue remarks from the claims.

Post decree abstracts of the water right claims reflecting the recommended changes are attached to this Report.
