MASTER’S REPORT

Claim 41S 146441-00 appeared in the Preliminary Decree for the Judith River (Basin 41S) and received an objection from the Montana State Board of Land Commissioners (“TLMD”). The claim was consolidated into case 41S-0030-R-2024 on March 27, 2024. On May 14, 2024, the parties filed a Stipulation requesting that claim 41S 146441-00 be withdrawn, stating the claim was redundant with claim 41S 128229-00.

FINDINGS OF FACT

1. Patty Erickson is the listed owner of the above-captioned claim. The Request to Withdraw claim 41S 146441-00 is unambiguous.
2. The claim should be withdrawn pursuant to the clear intent of the Stipulation.

PRINCIPLES OF LAW

1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(12), MCA.

CONCLUSIONS OF LAW

1. Upon review of the case file and the documentation submitted by the parties, the record is clear that claim 41S 146441-00 should be dismissed. The intent to withdraw the claim was unambiguous and the parties have filed documentation stating the same.

RECOMMENDATIONS

1. Upon review of the case file, the record in this case, and the evidence presented, claim 41S 146441-00 should be dismissed.
