MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Judith River (Basin 41S) and received issue remarks placed on the claims during reexamination of the claims by the Department of Natural Resources and Conservation ("DNRC") as well as objections from claimant McMillan Trust.

On February 12, 2024, the claims were consolidated into case 41S-0067-R-2024 (Doc. 100). On April 26, 2024, the McMillan Trust ("Trust") filed a Status Report detailing the Trust's proposed resolution to their objections (Doc. 2.00). Attached to the Status Report was an affidavit of Scott Irvin. On July 1, 2024, the Trust filed additional information regarding claim 41S 139535-00 (Doc. 4.00).

FINDINGS OF FACT

1. Pursuant to the status report, the Trust proposes adding the following points of diversion and places of use to claim 41S 48770-00:

- 2. The affidavit states that "[a]ccording to Dean McMillan" stock historically accessed Cottonwood Creek at these locations.

THE CLAIMED MEANS OF DIVERSION MAY BE INCORRECT AND CANNOT BE CONFIRMED DUE TO LACK OF DATA.

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE. THE FERGUS COUNTY WATER RESOURCES SURVEY (1970) APPEARS TO INDICATE 22.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

4. The status report states that while the means of diversion is correct, the legal description is not. The report states that the POD is in the S2SWNW S26 T15N R17E and includes a 1968 aerial photograph showing the location of the POD. The affidavit

attached to the report states that the POU should be reduced to 22 acres and provides supportive analysis for the reduction.

- 5. Pursuant to the status report, the Trust proposes modifying the source for claim 41S 115273-00 to 'groundwater' (Spring, Unnamed Tributary of Middle Fork Big Spring Creek) and the means to diversion to 'developed spring' and the flow rate to 20 GPM. The affidavit states that the spring is a developed, manmade spring.
 - 6. Claim 41S 115275-00 was decreed with the following substantive issue remark:

THE CLAIMED PRIORITY DATE MAY BE QUESTIONABLE. THE PRIORITY DATE ON THE SUBMITTED NOTICE OF APPROPRIATION IS 05/10/1886.

- 16. The Trust's July 1, 2024 filing includes an affidavit and review of 1972 imagery which Scott Irvin states shows 19 acres of irrigation. The filing also states that the flow rate should be corrected to 500 GPM as originally claimed. The filing states that 500 GPM is the capacity of the pump. Finally, the Trust agrees with the priority date issue remark in that the priority date of the claim should be May 10, 1886.
- 17. Scott Irvin's Affidavit states that in essence, claims 41S 139537-00 and 41S 139538-00 inadvertently claimed each other's domestic right. In order to correct the error, the Trust objected to the claims.
- 18. The Affidavit further states that the following modifications should be made to claim 41S 139537-00 to properly reflect historical use:

THE TIMELY FILED OBJECTION OF UNITED STATES OF AMERICA WAS AMENDED BY AGREEMENT OF THE PARTIES TO INCLUDE POINT OF DIVERSION AND PLACE OF USE BECAUSE THESE ELEMENTS WERE NOT INCLUDED ON THE OBJECTION LIST, ANY WATER USER WHOSE RIGHTS MAY BE ADVERSELY AFFECTED BY ENFORCEMENT OF THESE CHANGES MAY PETITION THE APPROPRIATE COURT FOR RELIEF OR MAY FILE AN OBJECTION AT THE PRELIMINARY DECREE.

SOURCE NAME, MEANS OF DIVERSION, POINT OF DIVERSION, AND RESERVOIR RECORD WERE MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 3. Section 3-7-224, MCA the Water Court is directed to conduct hearings in the same manner as for other civil actions. The Water Court applies the Montana Rules of Civil Procedure (M.R.Civ.P.), the Montana Rules of Evidence (M.R.Evid.) and the Montana Uniform District Court Rules. This Master considers documents (including objections) filed with the Court as "other paper" under M.R.Civ.P. Rule 11(b)(3) which certifies that to the best of the parties knowledge the factual contentions contained within the Statement are supported by evidence.
- 4. Add to this rule the recognition that "the heart of a judicial process is the development of the truth through conflict between parties with adverse interests." United States of America (USDI) –Bureau of Indian Affairs)-General Objection to Basin 42B and 42C Preliminary Decrees, Case 42B-1, ¶ 3 at p. 14, (Order Denying Motion June 27, 2014). Considering these tenets, significant weight is given to the filings to establish the accurate historical use of the claims.

CONCLUSIONS OF LAW

1. The modifications proposed by the Trust as discussed in Findings of Fact #1, 4, 5,

7, 8, 10, 11, 12, 15, 17 and 18 overcome the prima facie status of the claims and should be adopted.

2. Adoption of the modifications resolves the objections and the substantive issue remarks on the claims.

3. The 'notice' type issue remarks on claims 41S 115273-00, 41S 115275-00, 41S 115276-00, 41S 115277-00 and 41S 115278-00 have served their purpose and require no additional proceedings to resolve. The remarks should be removed.

RECOMMENDATIONS

- 1. The claims should be modified as discussed above.
- 2. Modification of the claims resolves the substantive issue remarks on the claims and the remarks should be removed.
- 3. The modifications resolve the objections to the claims and the objections should be dismissed.
- 4. The 'notice' type remarks require no proceedings to resolve and should be removed from the claims.
