MASTER'S REPORT

FINDINGS OF FACT

 Kolstad Livestock Co. is the record owner of domestic claim 41S 162195-00.

2. Claim 41S 162195-00 was decreed with a 7.00 acre-feet volume and the following DNRC issue remark:

ON 07/07/2000 HOWARD KOLSTAD FILED A LATE OBJECTION TO CHANGE THE VOLUME TO 3.14 ACRE FEET PER YEAR. THIS WILL BE HEARD AFTER PROPER NOTICE ON THE NEXT OBJECTION LIST.

The issue remark referenced a July 7, 2000 letter and Affidavit filed by Howard Kolstad, president of Kolstad Livestock Co., indicating the volume for claim 41S 162195-00 should be reduced to 3.14 acre-feet (2.00 acre feet for household irrigation and 1.14 acre-feet for lawn and garden irrigation). Copies of the documents are available in the claim file.

3. The deadline to file objections in Basin 41S was August 4, 1984. Therefore, Water Master Kathryn Lambert sent a letter to Kolstad Livestock Co., explaining that an issue remark would be added to claim 41S 162195-00, and Howard Kolstad's letter would be docketed as a late objection to be addressed after notice in the Preliminary Decree.

PRINCIPLES OF LAW

1. The Water Court must address all issue remarks decreed on a claim as well as any objections the claim receives. Sections 85-2-233, 85-2-247, and 85-2-248, MCA.

2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.

3. If a claimant agrees to reduce or limit an element of a claim, the water court may accept the claimant's requested reduction or limitation without further presentation of evidence unless there is an unresolved issue remark on the claim, in which case § 85-2-248, MCA must be applied. Rule 17(c), W.R.Adj.R..

CONCLUSION OF LAW

1. The volume of claim 41S 162194-00 should be reduced, as proposed by Kolstad Livestock Co., resolving the issue remark decreed on the claim.

RECOMMENDATIONS

1. The volume of claim 41S 162194-00 should be reduced to 3.14 acre-feet.

2. The issue remark should be removed from the claim.

A Post Decree Abstract of Water Right Claim is served with the Report for review.
