This Master's Report was filed with the Montana Water Court on the above stamped date. <u>Please review this report carefully.</u>

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for Box Elder Creek (Basin 39E) and received objections from the United States of America (Bureau of Land Management) ("BLM")

The BLM objections seek to removal of the following remark from the claims:

THE WATER RIGHTS LISTED FOLLOWING THIS STATEMENT ARE MULTIPLE USES OF THE SAME RIGHT. THE USE OF THIS RIGHT FOR SEVERAL PURPOSES DOES NOT INCREASE THE EXTENT OF THE WATER RIGHT. RATHER IT DECREES THE RIGHT TO ALTERNATE AND EXCHANGE THE USE (PURPOSE) OF THE WATER IN ACCORD WITH HISTORICAL PRACTICES.

The claims were decreed with the following issue remarks:

39E 61136-00

MEANS OF DIVERSION WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

PURSUANT TO WATER COURT ORDER, IF NO OBJECTIONS TO THIS CLAIM ARE FILED, THE CLAIMED VOLUME OF .56 ACRE-FEET WILL BE REINSTATED.

MEANS OF DIVERSION WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

POINT OF DIVERSION, MEANS OF DIVERSION, AND RESERVOIR RECORD WERE MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

PURSUANT TO WATER COURT ORDER, IF NO OBJECTIONS TO THIS CLAIM ARE FILED, THE CLAIMED VOLUME OF .93 ACRE-FEET WILL BE REINSTATED.

The claims were consolidated into Water Court Case 39E-0241-R-2024 on April 11, 2024 (Doc. 100) and an Order Setting Filing Deadline was issued. The Order required the parties to contact the Court to state their position on the removal of the 'multiple use' remarks by May 12, 2024. The order stated that "[f]ailure to comply with this filing deadline will be viewed as agreement that the remarks should be removed from the claims".

On May 7, 2024, the BLM filed a Response to Court Order, stating that it supported the removal of the 'multiple use' remarks. Claimant L&L Ranch, Inc. (L&L Ranch) failed to respond to the Order.

FINDINGS OF FACT

- 1. No objections were filed to the volume for claims 39E 61136-00 and 39E 61143-00. Accordingly, the volume should be reinstated pursuant to the issue remarks on the claims. Reinstatement of the volume resolves the issue remarks.
- 2. Pursuant to the objections and the April 11, 2024 Order, the 'multiple use' remarks should be removed from the claims.
- 3. The remaining remarks on the claims are 'notice' type remarks that do not require proceedings to resolve. The remarks state that if no objections were filed to the listed elements that they would remain as they appeared in the decree and the remarks would be removed. No objections were filed to the listed elements and the remarks should be removed accordingly.

PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(12), MCA.
- 2. If a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing, or fails to comply with an order issued by the water court, the water court, upon motion, or its own initiative, may issue such orders of sanction with regard thereto as are just. Rule 22, W.R.Adj.R. Sanctions applied against claimants may include termination of the water right claim. Rule 22, W.R.Adj.R.
- 3. Active participation by water users, especially claimants, is imperative for the accuracy of the statewide adjudication effort. *In re Korman*, 2014 Mont. Water LEXIS 17, *6. Further, "[t]he time required to process these cases is extended substantially when litigants do not comply with deadlines imposed by the Court." *Huntsman v*. *Huntsman Ranch Co.*, 2015 Mont. Water LEXIS 2, *6. It is within the power of this Court to terminate a water right claim if a claimant fails to participate. Rule 22. W.R.Adj.R.

CONCLUSIONS OF LAW

- 1. Claimant L&L Ranch has failed to participate, despite being given opportunity to do so. *See Order Consolidating Case and Setting Filing Deadline*, April 11, 2024 (Doc 1.00).
- 2. Accordingly, the record supports the removal of the 'multiple use' remarks on claims 39E 61136-00, 39E 61141-00 and 39E 61143-00.
- 3. Pursuant to the language of the volume issue remarks on claims 39E 61136-00 and 39E 61143-00 the volumes should be reinstated on the claims.
- 4. The remaining issue remarks have served their purpose and should be removed from the claims.

RECOMMENDATION

- 1. Upon review of the record in this case, the claims should be modified as discussed above.
- 2. The issue remarks have served their purpose and should be removed from the claims.
