

MASTER'S REPORT

Claim 41I 7075-00 appeared in the Preliminary Decree for the Missouri River above Holter Dam (Basin 41I) issued on June 24, 2022. The claim received an objection from Frank and Leisa McArthur. The claim also received an issue remark. Issue remarks are notations identifying potential legal or factual issues with water rights and the Water Court is required to resolve these potential issues.

FINDINGS OF FACT

- 1. Claim 41I 7075-00 appeared in the Basin 41I Preliminary Decree as a claim for sprinkler/flood irrigation that diverts water from Deep Creek via a headgate on Mitchell-Heuer Ditch 2 in the SESESW of Section 36, T7N, R2E, Broadwater County.
 - 2. The McArthurs objected, stating the point of diversion is in question.
- 3. The claim also received an issue remark stating that the point of diversion was modified by the DNRC during reexamination of the claim.
 - 4. The parties filed a settlement agreement. (Docs. ¹ 7.00, 8.00).
- 5. The settlement agreement requested the following modifications to claim 41I 7075-00:



6. The Statement of Claim listed the point of diversion and means of diversion as follows:

7. The point of diversion and means of diversion were amended by Claimant prior to issuance of the Basin 41I Temporary Preliminary Decree. No evidence was provided in support of the amendment.

8. The map attached to the statement of claim shows the point of diversion in Section 2, T6N, R2E, Broadwater County:



9. The modifications proposed in the settlement agreement restore the point of diversion and means of diversion to how they were originally claimed.

PRINCIPLES OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R.
- 2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.
- 3. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).
- 5. The Water Court is not bound by parties' settlement agreements. Any settlement reached by the parties is subject to review and approval by the Water Court. Rule 17(a), W.R.Adj.R.

CONCLUSION OF LAW

1. The objection overcomes the prima facie status of claim 40A 7075-00. The evidence in the claim file shows the point of diversion is a pump in the NENESW of Section 2, T6N, R2E, Broadwater County. Modification of the point of diversion and means of diversion resolves the objection and the point of diversion issue remark.

RECOMMENDATIONS

1. Claim 41I 7075-00 should be modified as follows:

*Point of Diversion and Means of Diversion:

PUMP IS SECONDARY MEANS OF DIVERSION.

2. The issue remark should be removed from claim 41I 7075-00.

A post decree abstract of the water right claim reflecting the recommended changes is attached to this Report.
