NOTICE OF FILING OF MASTER'S REPORT

This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Missouri River above Holter Dam (Basin 41I) issued on June 24, 2022. The claims are co-owned by Connie Shindoll and the Albert N. Shindoll Trust. The claims received issue remarks. Issue remarks are notations identifying potential legal or factual issues with water rights and the Water Court is required to resolve these potential issues.

FINDINGS OF FACT

41I 27404-00

- 1. Claim 41I 27404-00 appeared in the 41I Preliminary Decree as a claim for stock drinking directly from Spring No. 4 in the SESENW of Section 35, T7N, R3E, Broadwater County.
 - 2. The claim received the following issue remark:

ON 08/14/2002 CONNIE E. SHINDALL FILED A LATE OBJECTION TO CHANGE THE PLACE OF USE AND POINT OF DIVERSION LEGAL DISCRIPTIONS. THIS WILL BE HEARD AFTER PROPER NOTICE ON THE NEXT OBJECTION LIST.

- 3. The Statement of Claim was filed by Shindoll Ranch, who claimed the point of diversion and place of use as it appeared in the 41I Preliminary Decree. The 2002 amendment requests modifying the township from 7N to 8N. According to the amendment, T7N was claimed in error. The 2002 amendment was taken as a late objection for purposes of adding the issue to the Basin 41I Preliminary Decree Objection List.
- 4. ML Bar Ranch LLC owns the entirety of Section 35, <u>T7N</u>, R3E, Broadwater County while Connie Shindoll owns the entirety of Section 35, <u>T8N</u>, R3E, Broadwater County.
- 5. Claimant filed a statement confirming the township of the point of diversion and place of use should be corrected from 7N to 8N. (Doc. 16.00).

41I 27406-00

6. Claim 41I 27406-00 appeared in the 41I Preliminary Decree as a claim for a stock well in the NESENW of Section 11, T7N, R3E, Broadwater County.

7. The claim was decreed with a 40.00 gallons-per-minute (GPM) flow rate. The claim received the following issue remark:

THE CLAIMED FLOW RATE EXCEEDS THE 35 GPM GUIDELINE FOR THIS PURPOSE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA.

- 8. The Statement of Claim claimed 40.00 GPM, however the Declaration of Vested Groundwater attached in support of the Statement of Claim listed a flow rate of 30.00 GPM.
- 9. Based on the conflicting flow rates, Claimant's statement requested that the flow rate be reduced to 35.00 GPM.

41I 27415-00

- 10. Claim 41I 27415-00 appeared in the 41I Preliminary Decree as a claim for a domestic well in the NWSESE of Section 3, T7N, R3E, Broadwater County. The claim was decreed with a priority date of December 27, 1963.
 - 11. The claim received the following issue remark:

THE PRIORITY DATE AND TYPE OF RIGHT IS IN QUESTION. THE SOURCE ON THE FILED NOTICE OF COMPLETION (FORM GW3) APPEARS TO BE DIFFERENT FROM THE CLAIMED SOURCE.

- 12. The filed Notice of Completion does not list a specific source name, but the markings on the map are consistent with the claimed location of the well. There are no notes in the claim file supporting the issue remark.
- 13. Claimant confirmed that the elements of 41I 27415-00 were accurately claimed and decreed.

41I 27416-00

14. Claim 41I 27416-00 appeared in the 41I Preliminary Decree as a claim for a developed spring in the SENWNW of Section 6, T7N, R4E, Broadwater County. The claim was decreed with a flow rate of 40.00 GPM. The claim received the following issue remark:

THE CLAIMED FLOW RATE EXCEEDS THE 35 GPM GUIDELINE FOR THIS PURPOSE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA.

15. The Statement of Claim claimed 40.00 GPM, however the Declaration of Vested Groundwater attached in support of the Statement of Claim did not list a specific flow rate. The Declaration references 15 miner's inches. There is no evidence supporting the issue remark.

PRINCIPLES OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R.
- 2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.
- 3. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).
- 5. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
- 6. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.
- 7. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

CONCLUSIONS OF LAW

41I 27404-00

1. The late objection overcomes the prima facie status of claim 41I 27404-00. The evidence in the claim and case files shows the township of the point of diversion and place of use for claim 41I 27404-00 should be corrected from 7N to 8N.

41I 27406-00

2. The flow rate issue remark overcomes the prima facie status of the claim. Based on the conflicting evidence in the claim file, the flow rate of claim 41I 27406-00 should be reduced to 35.00 GPM.

41I 27415-00

3. The priority date issue remark does not overcome the prima facie status of claim 41I 27415-00. The evidence attached to the statement of claim is consistent with the priority date and source claimed.

41I 27416-00

4. The flow rate issue remark does not overcome the prima facie status of claim 41I 27416-00. There is no evidence supporting placement of the issue remark and the evidence attached to the statement of claim shows the flow rate is 40.00 GPM.

RECOMMENDATIONS

- 1. The point of diversion and place of use for claim 41I 27404-00 should be corrected from 7N to 8N.
 - 2. The flow rate of claim 41I 27406-00 should be reduced to 35.00 GPM.
 - 3. The issue remarks should be removed from claims.

A post decree abstract of each water right claim reflecting the recommended changes is attached to this Report.
