## **MASTER'S REPORT**

The above-captioned claims appeared in the Preliminary Decree for the Missouri River Above Holter Dam (Basin 41I) issued on June 24, 2022. The claims are owned by

R & L Ranch Co. The United States Department of Agriculture, Forest Service (Forest Service) objected to the claims.

## FINDINGS OF FACT

1. Claim 41I 117781-00 appeared in the Basin 41I Preliminary Decree as a stock claim from a well in the NESESE of Section 35, T6N, R3E, Broadwater County. The claim was decreed with the following place of use:

2. The Forest Service objected to the claim, stating:

The statement of claim does not describe how water is conveyed from the well to places of use. The place of use may need to be co-located with the well.

- 4. Claim 41I 117790-00 appeared in the Basin 41I Preliminary Decree as a claim for stock drinking directly from Hudson Spring. The claim was decreed with the same place of use as claim 41I 117781-00.
  - 5. The Forest Service objected to the claim, stating:

The statement of claim does not describe how water is conveyed from the spring to places of use. Place of use may need to be co-located with the spring.

- 6. On June 6, 2024, the parties filed a stipulation resolving the United States's objections. (Doc. 1 8.00).
- 7. The stipulation proposes refining the place of use in Section 36, T6N, R3E, Broadwater County to the S2S2 of Section 36, T6N, R3E, Broadwater County.

# PRINCIPLE OF LAW

1. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.

# CONCLUSION OF LAW

1. The Court should approve the parties' stipulation and refine the place of use as requested.

# RECOMMENDATION

1. For claims 41I 117781-00 and 41I 117790-00, the place of use in Section 36, T6N, R3E, Broadwater County should be refined to the S2S2 of Section 36, T6N, R3E, Broadwater County.

A post decree abstract of each water right claim reflecting the recommended changes is attached to this Report.
