NOTICE OF FILING OF MASTER’S REPORT

This Master’s Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master’s Report within **10 days** of the stamped date if you disagree or find errors with the Master’s findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master’s Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master’s Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master’s Report.

MASTER’S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Missouri River above Holter Dam (Basin 41I) issued on June 24, 2022. The claims are co-owned

by Charles P. Hahn and Hahn Ranch. The claims received objections from the United States. The claims also received issue remarks. Issue remarks are notations identifying potential legal or factual issues with water rights and the Water Court is required to resolve these potential issues.

FINDINGS OF FACT

41I 24001-00 and 41I 24002-00

1. Claim 41I 24001-00 was decreed as a claim for water from an unnamed tributary of White Horse Creek. Claim 41I 24002-00 was decreed as a claim for water from White Horse Creek. Both claims were decreed for flood irrigation of the same 205.00-acre place of use:

2. The United States objected to both claims, stating:

Historical data, published in the Water Resources Survey, indicates 0.00 acres irrigated at the time the Survey was published. It appears the date of first beneficial use may be incorrect. 1979 and current aerial photography indicate less acres irrigated than claimed. The priority date, maximum acres, flow rate and place of use may need correction to conform to historic beneficial use.

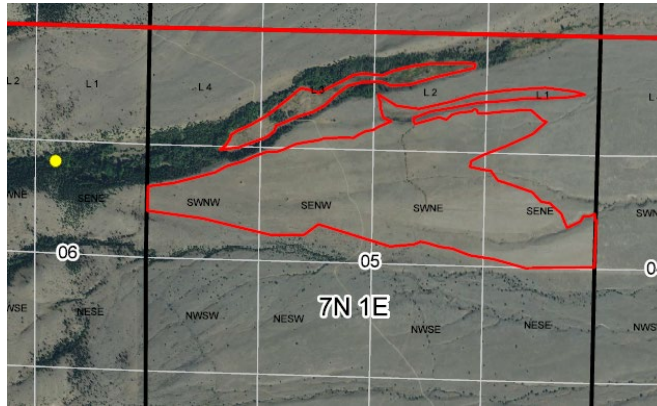
3. The claims also received the following issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
 THE BROADWATER COUNTY WATER RESOURCES SURVEY (1956) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
 THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

4. On May 30, 2024, the parties filed a stipulation. (Doc.¹ 4.00).

5. The stipulation requests the place of use and maximum acres for claim 41I 24001-00 and 41I 24002-00 be reduced to 140.00 acres in the N2 of Section 5, T7N, R1E, Broadwater County:

6. The stipulation states that Claimants irrigate 140.00 acres when water is available.

7. During the DNRC’s initial review of the claims, the DNRC examiner interviewed Charles Hahn. The examiner’s notes from the interview state:

The only concern about this claim was the maximum acres. Aerial Photo 479-113, dated 8-29-79 showed evidence of a ditch system, however the area did not look irrigated. The Broadwater County Water Resources Survey dated 1956 did not show irrigation taking place at the time of the survey.

I asked Mr. Hahn when the area was last irrigated. He said it was irrigated whenever water is available. The claimed area is used for pasture, not crop land. The area outlined on the mylar was completed with Mr. Hahn’s assistance. The acreage was not figured until nearly a month later. The amount fell well within the range.

The Water Resources Survey in Broadwater County probably did not map pasture irrigation. Subirrigation was also not taken into account. A PL51 remark was added noting the Survey did not show irrigation taking place. A second PL remark noted evidence of a ditch system.

8. Because the Water Resources Survey for Broadwater County did not map pasture irrigation, and claims 41I 24001-00 and 41I 24002-00 are used for pasture irrigation, the issue remark based on the Water Resources Survey does not overcome the prima facie status of the claims.

41I 24003-00 and 41I 24004-00

9. Claims 41I 24003-00 and 41I 24004-00 were decreed as claims for water from North Pole Creek. Both claims were decreed for flood irrigation of the same 73.00-acre place of use:

10. The United States objected to both claims, stating:

Historical data published in the Water Resources Survey and aerial photography do not support historical or current irrigation occurring as claimed. The claimed water right might not have been perfected, or if it was perfected, it was abandoned. All elements of this water right are questionable.

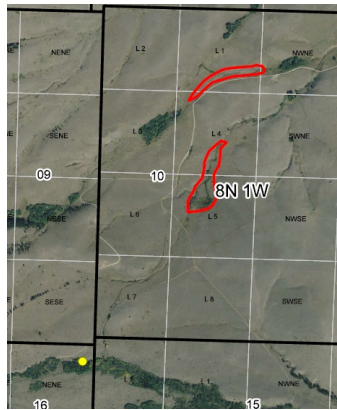
11. The claims also received the following issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
 THE BROADWATER COUNTY WATER RESOURCES SURVEY (1956) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
 USDA AERIAL PHOTOGRAPH NO. 479-53, DATED 8-29-79, SHOWS EVIDENCE OF A DITCH SYSTEM.
 THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE

12. The stipulation requests the place of use and maximum acres for claim 41I 24003-00 and 41I 24004-00 be reduced to 10.00 acres as follows:

13. The stipulation included a map of the proposed reduced place of use:



14. The stipulation states that Claimants are able to irrigate 10.00 acres when water is available.

15. During the DNRC's initial review of the claims, the DNRC examiner interviewed Charles Hahn. The examiner's notes from the interview state:

I asked Mr. Hahn when the area was last irrigated. He said it was irrigated whenever water is available. The claimed area is used for pasture, not for crop land. The area outlined on the mylar was completed with Mr. Hahn's assistance. The area outlined figured to be 64.0 acres. This is within the range.

It is not known what the Water Resources Survey in Broadwater County defines as 'potential' irrigation. The Survey probably did not map pasture irrigation. Subirrigation was also not taken into account.

16. Because the Water Resources Survey for Broadwater County did not map pasture irrigation, and claims 41I 24003-00 and 41I 24004-00 are used for pasture

irrigation, the issue remark based on the Water Resources Survey does not overcome the prima facie status of the claims.

17. Claims 41I 24003-00 and 41I 24004-00 also received the following notice-type issue remark:

DITCH NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

18. This remark served its notice purpose.

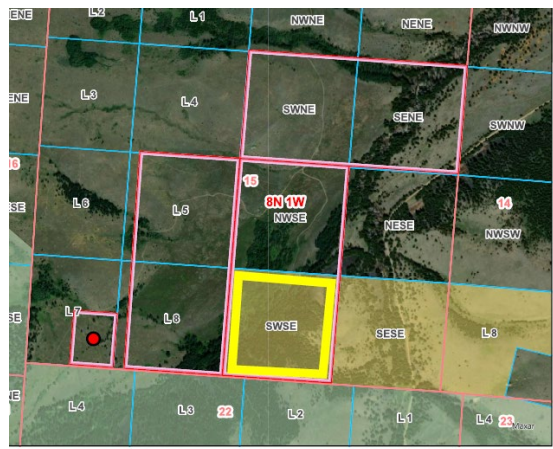
19. Claim 41I 24005-00 was decreed as a claim from South Pole Creek with a 72.00-acre place of use as follows:

20. The United States objected to the claim, stating:

The place of use as described includes federal land administered by the Bureau of Land Management (BLM). There is no authorization to irrigate federal land. Place of use ID No. 2 needs to be redefined to remove federal land in SWSE Section 15, Township 8N, Range 1W, Broadwater County. The acreage should also be readjusted appropriately. Removal of federal land from the place of use and readjustment in acreage would resolve BLM's objection.

21. The stipulation proposes modifying the legal land description of the 17.00-acre parcel in the W2SE of Section 15 to the NWSE of Section 15:



PRINCIPLES OF LAW

1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R.

2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.

3. A preponderance of the evidence is evidence that shows a fact is “more probable than not.” *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.

4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).

5. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.

6. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.

7. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

8. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.

9. The Water Court is not bound by parties’ settlement agreements. Any settlement reached by the parties is subject to review and approval by the Water Court. Rule 17(a), W.R.Adj.R.

CONCLUSIONS OF LAW

41I 24001-00 and 41I 24002-00

1. The objections overcome the prima facie status of claims 41I 24001-00 and 41I 24002-00. The evidence in the claim and case file shows by a preponderance of the evidence that the place of use and maximum acres is 140.00 acres in the N2 of Section 5, T7N, R1E, Broadwater County.

41I 24003-00 and 41I 24004-00

2. The objections overcome the prima facie status of claims 41I 24003-00 and 41I 24004-00. The evidence in the claim and case file shows by a preponderance of the evidence that the place of use and maximum acres is 10.00 acres in Section 10, T8N, R1W, Broadwater County.

3. The notice-type issue remark on claims 41I 24003-00 and 41I 24004-00 served its notice purpose.

41I 24005-00

4. The objection overcomes the prima facie status of claim 41I 24005-00. The evidence in the claim and case files shows the 17.00-acre parcel in the W2SE of Section 15 should be refined to the NWSE of Section 15.

RECOMMENDATIONS

1. The place of use and maximum acres for claims 41I 24001-00 and 41I 24002-00 should be reduced to 140.00 acres in the N2 of Section 5, T7N, R1E, Broadwater County.

2. The place of use and maximum acres for claims 41I 24003-00 and 41I 24004-00 should be reduced to 10.00 acres as follows:
