This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days to be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

The water right claims listed above appeared in the Preliminary Decree for the Missouri River above Holter Dam (Basin 41I) issued on June 24, 2022. The claims did

not receive objections but received issue remarks from the Department of Natural Resources and Conservation ("DNRC") raising potential legal or factual issues with the claims. The Water Court consolidated the claims into case 41I-2019-R-2024 to address the remarks.

On March 14, 2024, the Claimant filed a Concurrence with Proposed Resolution of Issue Remarks ("Response"), which states that the Claimant agrees with the modifications described in the Findings of Fact below. Doc. 2.00.¹

FINDINGS OF FACT

41I 89869-00

1. Water right claim 41I 89869-00 appeared in the Preliminary Decree as a claim for stock drinking directly from a spring that is an unnamed tributary of Beaver Creek. It received the following issue remark:

THE CLAIMED FLOW RATE EXCEEDS THE 35 GPM GUIDELINE FOR THIS PURPOSE AND CANNOT BE CONFIRMED DUE TO LACK OF DATA.

The quantified flow rate should be replaced with a standard information remark pursuant to Rule 24(b)(2) W.R.C.E.R. as follows:

Flow Rate: 1.25 CFS

A SPECIFIC FLOW RATE HAS NOT BEEN DECREED BECAUSE THIS USE CONSISTS OF STOCK DRINKING DIRECTLY FROM THE SOURCE, OR FROM A DITCH SYSTEM. THE FLOW RATE IS LIMITED TO THE MINIMUM AMOUNT HISTORICALLY NECESSARY TO SUSTAIN THIS PURPOSE.

41I 89872-00, 41I 89873-00, and 41I 89887-00

2. Claims 41I 89872-00, 41I 89873-00, and 41I 89887-00 received the following issue remark:

THE PRIORITY DATE MAY BE QUESTIONABLE. THE DATE OF FILING THE FORM GW2, NOTICE OF COMPLETION OF GROUNDWATER APPROPRIATION, IS 06/29/1973.

The Claimant agrees the priority dates should be corrected as suggested in the remark pursuant to the 1961 Groundwater Code. Doc. 2.00 at 2-3. The priority dates should be modified as follows:

June 29, 1973

3. Claims 41I 89872-00 and 41I 89873-00 also received the following remark:

THE PLACES OF USE FOR IRRIGATION CLAIM NO. 41I 89872-00 AND DOMESTIC CLAIM NO. 41I 89873-00 OVERLAP.

Claims 41I 89872-00 and 41I 89873-00 are multiple uses of the same water right. The use for irrigation and domestic on the same area alone does not present a legal or factual issue for the Court to resolve.

PRINCIPLES OF LAW

- 1. Section 85-2-248(2), MCA requires the Water Court to resolve all issue remarks that are not resolved through the objection process. The Montana Water Court has the authority to resolve issue remarks when the claim file and information available to the Court provide a sufficient basis to do so. § 85-2-248(3), MCA.
- 2. A properly filed claim of an existing right or an amended claim of existing right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R.
- 3. The claimant of a water right claim may waive the advantage of § 85-2-227, MCA by requesting a reduction or limitation of an element of a water right claim. The water court may accept a claimant's requested reduction or limitation without further presentation of evidence unless there is an unresolved issue remark on the claim. Rule 17(c), W.R.Adj.R.

CONCLUSIONS OF LAW

- 1. The Findings of Fact above are supported by a preponderance of the evidence. The priority date modification is a reduction the Court can accept without further analysis. The claims should be modified as described above.
- 2. The overlapping place of use issue remark fails to overcome the prima facie status of the claim. The remaining issue remarks are resolved by the modifications described above. The issue remarks should be removed from the claims.

RECOMMENDATIONS

Based on the foregoing Findings of Fact and Conclusions of Law, this Master recommends that the Court modify the claims as described above and remove the issue remarks from the claims.

A Post Decree Abstract of Water Right Claim for each claim reflecting the recommended changes is attached to this Report for review.
