If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

#### **MASTER'S REPORT**

Claim 41S 135365-00 appeared in the Preliminary Decree for the Judith River (Basin 41S) and was decreed with the following issue remarks:

FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

THE FERGUS COUNTY WATER RESOURCES SURVEY ( 1970 ) APPEARS TO INDICATE 64.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

USDA AERIAL PHOTOGRAPH NO(S). 30027-278-44 , DATED 09/25/1979 , APPEARS TO INDICATE 43.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

POINT OF DIVERSION WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

THE MAXIMUM COMBINED ACRES FOR THIS GROUP OF SUPPLEMENTAL CLAIMS MAY REQUIRE MODIFICATION PENDING RESOLUTION OF MAXIMUM IRRIGATED ACRES ISSUE.

The American Prairie Foundation (APR) and the United States of America Bureau of Land Management (BLM) filed objections to the claim.

On April 22, 2024, claimant APR filed a Motion to Amend Claim 41S 135365-00 (Doc. 16.00). The Motion requested several reductions to the claim. Attached to the motion is aerial imagery from 1954 and 1977 showing a total of 59.6 acres irrigated. An analysis of the 1979 aerial image referenced in the issue remark and showing 59.6 irrigated acres is also included with the Motion. The Motion notes that it is unclear why the DNRC examination concluded only 43 acres were irrigated.

On May 2, 2024, BLM filed a Statement Regarding Claimant's Motion to Amend (Doc. 7.00) stating that adoption of the proposed reductions would resolve the BLM's objection to the claim.

#### FINDINGS OF FACT

1. The Motion proposes modifying claim 41S 135365-00 as follows:

Flow Rate: 5.69 CFS 5.6 CFS

Maximum Acres: -150.00 59.6

#### PRINCIPLES OF LAW

- 1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.
- 2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 3. If a claimant agrees to reduce or limit a claim, the Water Court may accept the reduction or limitation without reviewing further evidence, unless an unresolved issue remark remains. Rule 17(c), W.R.Adj.R.

#### **CONCLUSIONS OF LAW**

- 1. The flow rate and place of use modifications discussed in Finding of Fact #1 should be accepted as a reduction.
- 2. The flow rate and place of use reductions resolve the flow rate issue remark as well as the issue remark referencing the Water Resource Survey. The remaining 'acres irrigated' issue remark fails to overcome the prima facie status of the claim given the post-1973 date the imagery was taken as well as the additional aerial images provided with the Motion. The remaining remarks should be removed as they fail to overcome the prima facie status of the claim.

3. Adoption of the requested reductions to the claim resolves the BLM objection.

#### RECOMMENDATIONS

- 1. The flow rate, place of use and maximum acres should be modified as discussed above.
  - 2. The issue remarks should be removed from the claim.
- 3. The BLM objection should be resolved upon adoption of the requested reductions to the claim.

A Post Decree Abstract of Water Right Claim is attached to this Master's Report for review.
