## **MASTER'S REPORT**

## FINDINGS OF FACT

- 1. The record co-owners of stock water claim 41S 12562-00 are James H. Turner and Joyce A. Turner. The record owner of irrigation claim 41S 13392-00 is Cristy Loose. The record owner of irrigation claim 41S 16506-00 is David J. Dirkson.
- 2. Claims 41S 12562-00, 41S 13392-00, and 41S 16506-00 are all based on the July 5, 1902 Thomas Nicholson right from Ross Creek for 50 miner's inches. Presently, the claims overclaim the Nicholson right, and the following DNRC issue remark was decreed on the claims:

THE TYPE OF HISTORICAL RIGHT, PRIORITY DATE, AND FLOW RATE MAY BE QUESTIONABLE. THE CLAIMS FOLLOWING THIS STATEMENT USE THE SAME FILED APPROPRIATION TO DOCUMENT THE RIGHT. THE COMBINED FLOW RATE FOR THIS GROUP OF CLAIMS EXCEEDS THE TOTAL OF THE ORIGINAL APPROPRIATION. 41S 12562-00, 41S 13392-00, 41S 16506-00

3. Claimants Cristy Loose (claim 41S 13392-00) and David J. Dirkson (claim 41S 16506-00) were ordered to meet with a DNRC employee to address the following unresolved issue remarks decreed on claims 41S 13392-00 and 41S 16506-00:

#### 41S 13392-00:

- FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
- THE JUDITH BASIN COUNTY WATER RESOURCES SURVEY (1963) APPEARS TO INDICATE 44.00 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.
- USDA AERIAL PHOTOGRAPH NO(S). 30045-179-110, DATED 09/17/1979, APPEARS TO INDICATE 43.20 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.
- THE CLAIMED VOLUME APPEARS TO BE EXCESSIVE FOR THE CLAIMED PURPOSE.
   THE CLAIMED VOLUME EQUALS 67.44 TIMES THE CAPACITY OF THE RESERVOIR.
- VOLUME MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.

## 41S 16506-00:

- FLOW RATE MAY REQUIRE MODIFICATION BASED ON RESOLUTION OF MAXIMUM ACRES ISSUE.
- THE JUDITH BASIN COUNTY WATER RESOURCES SURVEY (1963) APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
- USDA AERIAL PHOTOGRAPH NO(S). 30045-179-110, DATED 09/17/1979, APPEARS TO INDICATE 0.00 ACRES IRRIGATED.
- THE CLAIMED POINT OF DIVERSION IS IN QUESTION. THE LOCATION OF THE HEADGATE CANNOT BE IDENTIFIED FROM AVAILABLE DATA.

4. DNRC Water Resource Specialist Carli Bluhm filed a Memorandum regarding her review of the claims. (Doc.1 2.00). Ms. Bluhm indicated she was contacted by Cristy Loose and Ms. Loose stated she "had no objections to the findings of the DNRC." Ms. Bluhm also reported that she spoke with Nick Dirkson who was going to provide additional information, and none was provided. This Water Master assumes Nick Dirkson is related to David J. Dirkson.

Ms. Bluhm reported that she reviewed information in the claim files, aerial photographs, and the 1970 Fergus County Water Resources Survey to prepare the Memorandum and make the recommendations; a marked aerial photograph and a proposed abstract for claim 41S 13392-00 were attached to the Memorandum.

5. **Claim 41S 13392-00** (Cristy Loose): Ms. Bluhm indicated the following modifications represent the historical use of claim 41S 13392-00:


- 6. **Claim 41S 16506-00** (David J. Dirkson): Ms. Bluhm found no evidence to support an appropriation of water for claim 41S 16506-00. Ms. Bluhm recommended claim 41S 16506-00 be dismissed.
- 7. **Possible multiple use:** Claims 41S 12562-00 (James H. Turner and Joyce Turner) and 41S 13392-00 (Cristy Loose) appear to be multiple uses of the same historical water right. Multiple uses are more than one water historical appropriation used for different purposes.

Stock water claim 41S 12562-00 and irrigation claim 41S 13392-00 were both filed by James H. Turner and Joyce A. Turner on March 9,1981 using identical documentation. Based on available information, it appears the claims are multiple uses of the same historical right. Additionally, with the proposed dismissal of claim 41S 16506-00, adding a multiple use remark to claims 41S 12562-00 and 13392-00 resolves the over-filed notice of appropriation issue remark decreed on the claims.

8. An Order was on May 7, 2024, setting a deadline for Claimant Cristy Loose to file a statement agreeing or disagreeing with the following recommended changes to claim 41S 13392-00:



The Order indicated that if nothing were filed by the deadline, this Water Master would conclude that Cristy Loose agrees with the proposed changes and a Master's Report would be issued recommending the changes be made to claim 41S 13392-00.

The Order set a deadline for Claimant David J. Dirkson to file a statement agreeing or disagreeing that claim 41S 16506-00 be dismissed and indicated that if nothing were filed by the deadline, this Water Master would conclude David J. Dirkson agrees with the proposed dismissal.

And the Order set a deadline Claimants Cristy Loose, James H. Turner, and Joyce Turner agree or disagree that a multiple use information remark should be added to claims 41S 12562-00 and 41S 13392-00. The Order indicated that if nothing were filed by the deadline, this Water Master would conclude the Cristy Loose, James H. Turner, and Joyce Turner agree the multiple use remark should be added to the claims.

The Order included the following language:

Failure to comply with the terms of this Order may result in sanctions, <u>up to and including entry of default and termination of a water right claim or dismissal of objections</u>. Rule 22, W.R.Adj.R.

Nothing was filed by the deadline.

9. Upon review of the DNRC Memorandum and the May 7, 2024 Order, a clerical error was noted. The maximum acres and place of use total for claim 41S 13392-00 should have reflected 34.00 acres, rather than 44.00 acres, as follows:



# PRINCIPLES AND CONCLUSIONS OF LAW

- 1. The Water Court is required to address all issue remarks decreed on claims. Sections 85-2-247 and 85-2-248, MCA.
- 2. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA. This prima facie validity may be overcome by evidence showing that one or more elements of the claim are incorrect. This standard of proof applies to objectors or claimants objecting to their own water right claims. Rule 19, W.R.Adj.R., *Nelson v. Brooks*, 2014 MT 120; 375 Mont.86, 95; 329 P.3d 558, 564.
- 3. Under Rule 22, W.R.Adj.R., if a claimant, objector, or intervenor fails to appear at a scheduled conference or hearing or fails to comply with an order issued by the Water Court, the Water Court may issue such orders of sanction with regard thereto as are just.
- 4. Claims 41S 12562-00 and 41S 13392-00 were decreed with notice-type issue remarks. As no objections were filed, no further proceedings are needed.

# **RECOMMENDATIONS**

- 1. A multiple use information remark should be added to claim 41S 12562-00 and 41S 13392-00.
  - 2. Claim 41S 13392-00 should be modified as follows:



3. Claim 41S 16506-00 should be dismissed.
