This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

Claims 41I 11128-00 and 41I 11129-00 appeared in the Preliminary Decree for the Missouri River above Holter Dam (Basin 41I) issued on June 24, 2022. The claims are

owned by Cory L. Davis and Gloria J. Davis. The claims received issue remarks. Issue remarks are notations identifying potential legal or factual issues with water rights and the Water Court is required to resolve these potential issues. Elliott Ranch LLC and Joseph P. Nelson filed notices of intent to appear on each claim.

FINDINGS OF FACT

- 1. Claim 41I 11128-00 was decreed as a flood irrigation claim that diverts water from Big Springs via a headgate in the NWSESE of Section 6, T4N, R3E, Broadwater County.
- 2. Claim 11129-00 was decreed as a claim for livestock drinking from Big Springs Ditch and is a multiple use of claim 41I 11128-00.
 - 3. The claims received the following issue remark:

THE PRIORITY DATE IS QUESTIONABLE. CASE 921, BROADWATER COUNTY, DOES NOT SPECIFY A MONTH OR DAY BUT DECREED THE RIGHTS AS 'CONTEMPORANEOUS & WITHOUT PRIORITY AS BETWEEN SAID PARTIES'. THE CLAIMS FOLLOWING THIS STATEMENT ALL CLAIMED MAY 23, 1869. 41I 11117-00, 41I 11120-00, 41I 11122-00, 41I 11123-00, 41I 11124-00, 41I 11125-00, 41I 11125-00, 41I 11130-00, 41I 11131-00, 41I 11132-00, 41I 11133-00, 41I 11133-00, 41I 11133-00, 41I 11134-00, 41I 11135-00, 41I 11137-00, 41I 11138-00, 41I 11138-00, 41I 11138-00, 41I 11140-00, 41I 11141-00, 41I 11142-00.

4. Elliott Ranch LLC filed a notice of intent to appear on claim 41I 11128-00 and 41I 11129-00, stating:

Elliott Ranch LLC has water rights on Big Springs that may be impacted by any changes made to this water right. The purpose of this NOIA is to monitor and participate in the resolution of the DNRC Issue Remarks.

- 5. As stated in the issue remark, the claims list the same priority date May 23, 1869.
- 6. Elliott Ranch LLC filed a withdrawal of their notice of intent to appear on each claim if the priority date issue remark is removed and no changes are made to the claims.
- 7. Claims 41I 11128-00 and 41I 11129-00 also received the following notice-type issue remark:

SOURCE NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

8. The issue remark states the source name was modified as a result of DNRC review pursuant to Montana Water Court reexamination orders. The remark indicates that

if no objections are filed, the elements of the claim will remain as they appear on the abstract and the remarks will be removed. Neither of the claims received objections.

PRINCIPLES OF LAW

- 1. A properly filed Statement of Claim for an existing water right is prima facie proof of its content. Section 85-2-227, MCA; Rule 10, W.R.Adj.R.
- 2. Prima facie proof may be contradicted and overcome by a preponderance of the evidence. Rule 19, W.R.Adj.R.
- 3. A preponderance of the evidence is evidence that shows a fact is "more probable than not." *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.
- 4. If prima facie status is overcome, the burden shifts back to the claimant to demonstrate historical use. *79 Ranch v. Pitsch*, 204 Mont. 426, 432-33, 666 P.2d 215, 218 (1983).
- 5. Section 85-2-248(2), MCA, requires that the Water Court resolve all issue remarks that are not resolved through the objection process. *See also* Rule 7, W.R.Adj.R.
- 6. The Water Court may use information submitted by the DNRC, the Statement of Claim, and any other data obtained by the Court to evaluate a water right. Sections 85-2-227, -231(2), MCA.
- 7. When resolving issue remarks, the Water Court must weigh the information resulting in the issue remark and the issue remark against the claimed water right. Section 85-2-247(2), MCA. The factual evidence on which an issue remark is based must meet the preponderance of evidence standard before the prima facie status of a claim is overcome. 43Q 200996-00 et al., Order Establishing Volume and Order Closing Case, at 18, June 8, 2015.

CONCLUSIONS OF LAW

1. The priority date issue remark does not overcome the prima facie status of claims 41I 11128-00 and 41I 11129-00. All of the rights established by Case 921, Broadwater County claim the same priority date and no objections were filed to the priority date of claims 41I 11128-00 and 41I 11129-00. The priority date of the claims

should remain as it appeared in the Basin 41I Preliminary Decree, and the remark should be removed from the claims.

- 2. Because the priority date of the claims will remain the same, the notices of the intent to appear are withdrawn.
- 3. The notice-type issue remark provides notice of the changes made after completion of the Temporary Preliminary Decree proceedings and prior to issuance of the Preliminary Decree. The remark does not raise unresolved issues that need to be addressed. No proceedings are required to resolve the remark; the remark should be removed from the abstracts.

RECOMMENDATION

1. The issue remarks should be removed from claims 41I 11128-00 and 41I 11129-00.

A post decree abstract of each water right claim reflecting the recommended changes is attached to this Report.
